PRESIDENT'S REPORT

I continue to be pleasantly surprised at the resilience of our Organisation as we manage and adapt to challenges, as we have had to do during 2014. We farewelled our COO Corinne Barnard in June and I would like to thank and congratulate her on her guidance and dedication throughout the time she was with us. We have moved forward considerably during her tenancy and I wish her well in her future endeavours. Nadia Bleaken (our former Development Manager) was appointed to the role and I look forward to a long and productive tenure in this new capacity. There will be new challenges ahead, but I am confident we will continue to grow and prosper together.

We continue to hold our own with the larger Continental Confederations and have gained well deserved credit from the BWF management, who acknowledge our consistency and outcomes, particularly in the Shuttle Time and AusAid development areas. Sadly our Tongan Shuttle Time coordinator, Ahosivi Kaitapu passed away suddenly in October, a lovely lady who will be sadly missed by our badminton community in the Pacific. The PPDP programme, funded by BWF Development and ably organised by Ji Hyun Marr and Nadia Bleaken, continues to flourish with the results evident in the increased participation at events by our Pacific members. The Australasian U17 Championships/ June Bevan event saw the inclusion of an Oceania team which was comprised of members of the PPDP programme. There have been two sessions for developing Coaches from our region during the year, which will continue as BWF continues with their Coach Development programme, and the Shuttle Time Teacher, Tutor and student training continue. Nadia's report covers these programmes in more detail. As mentioned last year I believe we need to work towards an Oceania Training Centre, which would provide access to quality training, coaches, mentors and courses for the whole region in a central location. Perhaps we may have opportunities as a legacy from both the Sudirman Cup and Commonwealth Games.

We supported Development Officers (part time) in Tonga, Cook Islands and Tahiti. I reiterate, as I did last year, that funding is available for those who are committed and organised and our challenge is to get more members to accept the offer. Nadia has provided more detailed information in her report. Each of us, in our own regions need to develop good relationships with local, government and private organisations to

establish funding sources to enable continued growth. We need to reinforce that badminton is a viable sport in our region, enjoyable, family friendly, available to all, with added social and health benefits.

The commitment to tournaments in the region continues, driven primarily by Australia and New Zealand, however I look forward to 2015 with anticipation as our friends from Tahiti and New Caledonia work towards reinstating their events. Although we as an organisation may incur some additional costs in assisting with these tournaments, I believe the grass root promotion and development of our sport far outweighs this cost. I encourage all our members to look towards staging events, albeit smaller ones, as we must continue to evolve in this area. Australia goes from strength to strength with a very successful Super Series held in Sydney in June (sponsored by Destination NSW) coupled with the great achievement, at the November BWF meeting held in Lima, of Events Queensland and Badminton Australia of successfully bidding for the 2017 Sudirman Cup, to be held on the Gold Coast. I would like to acknowledge the hard work of our Events Board member Loke Poh Wong and the passion of Vice President of Nigel Skelt (who lobbied very hard and well) which contributed greatly to Australia's success.

The very successful New Zealand Open has also had an upgrade to a GP Gold and I look forward confidently to the continued success and growth of this event. In September, both the Badminton New Zealand Federation and Badminton Australia conducted tournaments which participated in the BWF initiated new scoring system trial of 5 sets to 11. The proposed new system was trialled in each Continent and feedback was sought prior to BWF meeting in Lima, Peru. The information gained led to the BWF Council deciding to implement a further trial period in 2017 as the data was not sufficiently conclusive to instigate the change at this time.

The Oceania Team and Individual Championships, once again held in Ballarat Victoria, in conjunction with the AGM, and were wonderfully successful with the event being live streamed for the first time. The enthusiasm and dedication to the event demonstrated by the Organising Committee was infectious and, while the on court effort was intense and of a high standard, many friendships were renewed and new ones made off court. The reinstating of the Thomas/

Uber Cup qualifiers by BWF will also provide another opportunity for our Oceania Nations to come together to compete, with the winner of the region moving to the finals. Previously the invitation was allocated to the highest ranked team from the region.

New Zealand and Australian players achieved success on court in international tournaments during the year and it was wonderful to see them competing at the Commonwealth Games in Glasgow 2014. There were some very strong performances from both those countries which bodes well for the future. Norfolk Island was also representing our region. I look forward to having greater numbers from the Pacific representing at the 2017 Sudirman Cup and 2018 Commonwealth Games on the Gold Coast. With this in mind we need to build our support in terms of coaches, umpires, referees and line judges. More officials must be a priority for us to engage with the upcoming major events. We need to encourage younger officials as Technical officiating is an integral part of growing our sport. There are also a multitude of opportunities through BWF events worldwide, it is our task to develop and qualify people to take advantage of those opportunities

I continue to encourage all our members to develop relationships with National Olympic Committees, and other relevant bodies, with regard to not only funding but also creating awareness of the sport and region. We are only a small population in a large area and, as such, continue to require assistance from our partners such as BWF, ONOC, and AusAid to assist with training and development for our region. However we must play our part to progress and up-skill people in our own region by utilising the avenues available to us. We have demonstrated that badminton as a sport is capable of growing in popularity in the Pacific region; we now have a proven record as a development game in schools and the community. We all recognise that physical activity gives us a level of personal pleasure and well-being from the experience. Being involved in a community activity is also a way to develop friends and have social contact while at the same time benefiting from the activity, so let's sell that positive experience to all; particularly funding agencies.

The BWF continues to fund all nations to the AGM and I encourage everyone to attend as it is an ideal opportunity for our Confederation members to meet, as well as attend a world class tournament.

To meet face to face enables us to discuss any issues and take decisions prior to the AGM, which I believe is invaluable. This year's BWF AGM in Delhi proved difficult for a number of members as many were unable to attend due to visa difficulties. However 2015 should not be a problem and I urge you to attend, if at all possible.

At the recent meeting in Lima, Peru, the BWF reaffirmed its commitment to fighting illegal betting, match fixing and corruption in sport by signing up to the International Olympic Committee's Integrity Betting Intelligence System (IBIS), joining several other Olympic Sports. As an intelligence-sharing digital platform, IBIS will enable BWF and its 180 members associations to access an extensive network of monitoring and data-sharing across sports, event owners and the major sports-betting entities.

With Badminton now admitted to the 2020 Para Olympics we must do more in this area with a particular focus on building to the Tokyo 2020 Games. I know that BA recently joined the newly formed National Sport Inclusion Alliance (NSIA) who is keen to work on early intervention with multiple organisations to establish meaningful partnerships in order to provide pathways into badminton. Both BWF Para Badminton Committee and the BWF Development Committee are committed to supporting Confederations to deliver a great result in Tokyo for our first badminton Para Olympics. It is our task in Oceania to liaise with these Committees and develop badminton athletes from Oceania.

Our small but committed and energetic staff, supported by our Board members, has worked hard all year to assist and develop our sport; however each and every one of us need to commit to the badminton cause. Communication and interaction is vital for any organisation, particularly one as widespread as we are so I urge us all to use our contacts, make links within other organisations and develop the badminton community. We must all strive to improve efficiency, delivery of programmes and participation in the sport, as well as lifting the profile of our sport by developing elite players.

During this year I have been guided and assisted by our COO Corinne until her resignation and look forward to working with Nadia in her new COO role. It is particularly difficult task to work effectively with limited resources, financial pressure and big ideas but

we will continue to achieve. My thanks also go to Nadia in her previous role as Development Manager as her constant effort and enthusiasm inspired us all, and Bob Lindberg for his efforts with our accounting system. I would also acknowledge the assistance of BWF Development staff, Stuart Borrie and Ian Wright. Their advice and friendship is invaluable.

The challenge is there for us all but I believe 2015 will be successful and rewarding.

CHIEF OPERATING OFFICER'S REPORT

I'd like to thank everyone for welcoming me into my new role as Chief Operating Officer of Oceania Badminton.

Most importantly, on behalf of all of us, I would like to thank Corinne Barnard for all of her great efforts over an extended period of time. Badminton Oceania certainly made major steps during her tenure of which we are very grateful for her time, effort and dedication. While I am finding this role is a big new challenge, there are many exciting times ahead made even better with all of the great people involved within our region.

2014 has certainly been a challenging year of change. Again our limited resources have been stretched to capacity to continue delivery of key programmes. I'll attempt to summarise the highlights below whilst other reports give details specific to their area.

Our main income stream has been from grants from Badminton World Federation (BWF), with support also from Oceania National Olympic Committee (ONOC). This year our major achievement has been to enter a new partnership with the Australian Government.

The Pacific Sports Partnerships (PSP) is an Australian Government program funded by the Department of Foreign Affairs and Trade through the Australian Aid program and managed by the Australian Sports Commission. Badminton Australia and Oceania Badminton are supported through PSP to build the capacity of both Tonga and Kiribati Badminton federations to conduct quality sport for development programs.

Our audited accounts reflect a positive balance of our financial position. Changes in the coming year will include more stringent accountability reporting for each of our ongoing projects.

The BWF base grant funding and contestable funding levels have increased slightly. This reflects the continued support BWF give Continental Confederations to deliver their global development projects such as Shuttle Time Schools Badminton, Coach Education and Player Development.

As our organisation continues to grow, we will be looking to create and implement effective marketing and communication plans in the coming year.

The success of our programmes and projects to date are the result of the extremely hard work and dedication of

very talented people including:

- Ji Hyun Marr who tirelessly and enthusiastically delivers the coaching for our Pacific Player Development Programme for both athletes and their coaches.
- The most sad news for Badminton in Oceania, Tonga and Shuttle Time around the world was the sudden passing of Ahosivi Kaitapu our Tonga PSP Coordinator. Her sterling work establishing the programme was recognised not only in Tonga, but around the globe. Sivi was a great connector of people, the glue that made things happen, and a tireless worker who was working on reports until 2AM the night before she died. We will miss her greatly.
- The Australian Sport Commission PSP team and Badminton Australia, key partners in this fantastic opportunity to utilize Shuttle Time as a vehicle to develop active and healthy communities.
- Our Development Officers, Leo in Tahiti, Eric in the Cook Islands and Lauti with Tonga's PSP Project. Thank you for your enthusiasm delivering Shuttle Time to teachers and children.
- Our Board: Geraldine Brown, Nigel Skelt, Loke Poh Wong, Sandra Low, Michelle Hollands and Leody Vainikolo for your efforts. Particular thanks Geraldine and Nigel who are also on the BWF Council and put in a lot of travel to various meetings around the globe for the governance of our sport.
- Our Events Committee for their huge efforts behind the scene. Congratulations to Loke Poh Wong and the Badminton Australia team for a huge effort to undertake a successful Super Series event, as well as winning the bid to host Sudirman Cup in 2017... exciting times for Oceania!
- Also huge thanks to Rhonda Cator and the team at Ballarat Badminton for hosting a fantastic Kumpoo Oceania Championships in February 2014.
- Special mention to the determination of Julie Carrel and her New Zealand Open team who have upgraded to a GPG for 2015, and also are hosting us at North Harbour for Oceania Champs 2015.
- Peter Cocker and our Technical Officials Committee who put in a lot of work to organise our court

officials. I would like to make special mention of the small group of umpires, referees and line judges that give up their holidays and often pay for themselves to travel the world to officiate at events.

- I would like to congratulate those assessed to BWF level during 2014. Both Julie Carrell and Yogen Bhatnagar were assessed to BWF accredited referee. Trish Gubb was assessed to BWF certificated umpire and Jiten Bhatt was assessed to BWF accredited umpire. There is funding available from BWF to develop Pacific referees and umpires to BWF level. It is a major challenge for us as a region to develop a realistic plan toward universality.
- Our Women In Badminton Committee who met in Guam in May to develop a strategy for the utilisation of funding to assist in the equality of our sport.
- To our major partner the BWF for your ongoing support. Particular thanks to the development department with whom we met again in September in Kuala Lumpur for our annual Confederation meetings. Fantastic progress is being made in this area thanks to continued communication and support. Thanks also to the events department, who have joined this annual fixture and with whom we are building closer ties for the benefit of events in our region.
- I would like to acknowledge our key regional sports partners ONOC and OSFO.
- Also thanks to all of our key partners and sponsors including Kumpoo.

All of the badminton in Oceania community would like to sincerely thank all of the volunteers within our member federations and their families for their most valued contributions over the past year. Our volunteer network is by far the most valuable asset in our organisation and we thank you for sharing your passion for our game.

We look forward to the coming year, united to achieve the aim of positive growth in all areas of our business, on and off the court.

REGIONAL DEVELOPMENT MANAGER'S REPORT

With the support of the Badminton World Federation, development continues to be a huge growth area for Oceania Badminton. The four key priority areas of Shuttle Time Schools Badminton, Coach Education, Membership / capacity building and Player Development have all progressed significantly during 2014.

SHUTTLE TIME SCHOOLS BADMINTON

The BWF Shuttle Time Schools Badminton Programme continues to be our number one development priority, and is introducing our sport to large numbers of children around the region. During 2014 it has been fantastic to see the program continue to gain traction in a number of countries.

Some of our highlights include:

- Shuttle Time is the vehicle for the delivery of quality sport for development programs through the Pacific Sports Partnerships (PSP). The program is underway in Tonga with an office and two staff in place educating 50 new teachers and delivering regular physical activity to 2000 children.
- Our National Badminton Development Officers (NBDO) in Tahiti and Cook Islands have utilized the program with a huge increase in the number of tutors and teachers trained to deliver safe and fun badminton lessons to children in schools, and large increases in community clubs.
- New Zealand undertook tutor and teacher training in March with 24 new participants educated. This has followed through with our regions largest numbers (42,000 children) engaged in Shuttle Time throughout the country.

- Shuttle Time Tutor and Teacher workshop in Guam with 13 new teachers certified and Shuttle Time as part of the University Summer Holiday camp. One tutor was also certified from the Federated States of Micronesia to deliver Shuttle Time to trainee teachers at the College of Micronesia.
- In conjunction with the Australian Open Super Series in Sydney and through generous support of Yonex, we undertook BWF's Equipment Donation Project which saw a large box of equipment donated to Tonga.

COACH EDUCATION

Up until now we have focused our coaching efforts on developing Shuttle Time as a grassroots community development programme. In 2014 we undertook BWF Level 1 Coach Education certification in conjunction with Badminton New Zealand. Martijn van Dooremalen of the Netherlands visited New Zealand on several during the year as part of Olympic Solidarity funding, and we utilized his experience to act as Tutor for the programme over two weekends in April and September. Participants experienced a variety of theory and practical components with 7 New Zealand and 3 Pacific coaches successfully completing their assessment as BWF Level 1 Coaches.

MEMBERSHIP / CAPACITY BUILDING

Oceania Badminton has continued to work in partnership with the Oceania Sports Education Program (OSEP) to deliver sport training (for coaches, officials and administrators) to support the development of sport volunteers and professionals within our Pacific membership.

A key development within OSEP, is the Readiness Assessment Tool (RAT). We now require all of our Member Federations to complete the RAT annually, working towards the "high development" benchmark—the capacity to deliver quality sporting activities. Thank you to those national federations who have helped us capture a picture of badminton across the region by making contributions to this annual report. The RAT is an ideal tool for us to assess our members and, gives us information as to common needs and where we can best help build capacity.

Communication is essential to a positive working relationship with our members. We have really tried



hard to expand our communication platforms from email and website, to include social media. However, the best form of communication is face-to-face discussion, which we can now achieve twice a year with the Oceania events in February as well as the BWF supporting Members to attend their AGM in May.

PLAYER DEVELOPMENT

Player development is a strategic priority for the Badminton World Federation (BWF) through to Rio Olympics and the BWF have invested heavily in this area. The aim of this investment is:

- to create clear achievable well supported pathway for talented players from less developed and developing Members
- to increase the number of players regularly participating in international competition
- to increase the universality at our Continental Championships
- to increase the universality of top 200 world rankings and new Members eventually represented at World Championships and Olympic level

During 2014 we undertook training camps in conjunction with:

- Oceania Champs and Australian Junior International, Ballarat—February
- NZ Open, Australasian U17/combined Oceania June Bevan team and BWF Coach Education, Auckland—April
- Auckland International and BWF Coach Education, Auckland—September

Huge thanks to Pacific Player Development Program (PPDP) coach Ji Hyun Marr who enthusiastically inspires our athletes and coaches. Thanks also to our Pacific coaches who have committed to undertake Ji's program with their athletes at home. All participants have learned a huge amount in terms in intensity of training, movement and technique, and gained much more experience in match play, and look forward to competing again at the Oceania Champs at North Harbour in February 2015.

Again, my wholehearted thanks to every single person who has contributed to the growth of badminton within Oceania in 2014. Our volunteers are our lifeblood and I truly appreciate your enthusiasm, energy, time, effort and commitment to the development of badminton.

4. SKYCITY NEW ZEALAND OPEN GP

6. THE STAR AUSTRALIAN OPEN SUPER SERIES

This event was held in the Sydney Olympic Park Sports Centre. It is a Super Series with prize money of US\$750,000. At the close of entry over 250 players from 23 countries registered to compete with between 6–8 of the world top-10 ranked players in each event category competing. All the current world champions (from 2013) from each of the category had entered to compete.

In total over 12,000 spectators attended the 6-day event with sold out stadium seating for the finals. A report from Repucom indicates the reach of the televised matches to close to 300 million households.

- increased exposure for talented players at the international level
- profile building of the sport through our event strategy
- ongoing work around Governance
- continued growth in sponsorship and strategic partnership areas
- capacity to continue to assist members with event hosting and the CALD program
- refinement of the website, national ranking scheme and use of national rankings for national events
- steady growth in registration and participation numbers
- continuation of the National Insurance Program and further work on a database
- growth in the number of coaches and technical officials
- an enhanced role by BA internationally at the Oceania and BWF levels including our excellent officials
- commencement of work around a new 2015–18 Strategic Plan
- preparation of a major successful bid to host the BWF AGM and Sudirman Cup in 2017
- ongoing efforts to enhance performance

GOVERNANCE

During the year BA was registered as a Registrable Australian Body under the seal of ASIC (ARBN 168 493 365). Efforts to become a Company limited by Guarantee, continues to be part of the Constitutional changes.

Considerable work continued in the first part of the year to agree a new Constitution incorporating the ASC Mandatory Governance Principles. Fundamental to good governance is election of the Board by the

Members, the Board empowered to determine the strategy and policy and the Chief Executive Officer responsible for day to day management. The Board will continue to pursue with Members the new Constitution.

The Board functions to achieve what is best for the sport nationally. As an independent Board national interests are paramount and if there are potential conflicts of interest they are addressed in a transparent and appropriate manner.

The Board currently has six members, five elected and one appointed. The Board met formally on five occasions, conducted a number of teleconferences, was represented at all BA Events and corresponded significantly between meetings.

The Board determines Policy and Strategic Directions and the management, led by the CEO, looks after day to day operations—good governance resulting in continued progress.

The Current Strategic Plan (2010–2014) expires at the end of the year. Input has been sought from Members and Stakeholders with a view to a new Plan for 2015–2018 which fundamentally will build on the current framework

ANNUAL FINANCIAL REPORT 2013–2014

There was significant budget growth in 2013–2014 as reflected in the financial report elsewhere in this report. Expenditure, largely associated with the Super Series Event, increased substantially. Increased revenue was received from the ASC for the Pacific Partnership Program (in co-operation with Oceania), and increased sponsorship and strategic partner investments linked to the Super Series. The Board continued with its policy of not increasing Members fees (other than by CPI)—a policy now in place for four years.

Revenue in 2013/14 grew to \$3,382,758, a significant jump over the previous year.

HIGH PERFORMANCE

We increased our coaching resources by engaging Tracey Hallam who brings extensive playing experience at the highest level. We did well in the Oceania Championships, gained good experience at the Uber Cup and attended a range of International Events—summary of results are elsewhere in the report. Our

challenges in the High Performance area continue to be around better talent programs at the State level, continuing to improve our international performances and securing ongoing funding to ensure our players are able to compete more often overseas. We appreciate the AIS/ASC Winning Edge support and encourage the AIS/ASC to recognise the ongoing need to help developing sports such as ours. Podium finishes are only one part of High Performance.

FEDERAL GOVERNMENT LIAISON

We continued to work with the very helpful team at the Australian Sports Commission and Australian Institute of Sport. The AIS Winning Edge Strategy sees badminton as an important developing sport and it is essential this continues if we are to achieve podium finishes. The ASC's approach to participation is continuing to be developed and BA will continue dialogue to secure ongoing support. We will also maintain dialogue on the new Sport in Schools initiative and increase our efforts to grow Shuttle Time.

We met all reporting obligations, compared favourably with other NSOs in the Financial Benchmarking Report and have received an ongoing commitment in 2014/2015 for Participation Funding. Some work is yet to be done on program development and implementation.

We were successful, in cooperation with Badminton Oceania, in securing a Pacific Sports Partnership grant of \$500,000 for the 2013–2017 period. We sincerely thank the BWF, especially Stuart Borrie for his assistance with our submission. The purpose of this grant is to support Badminton Australia and Badminton's Pacific regional and National Sports Federations to achieve the following objectives; increased level of regular participation of Pacific islanders, including people with disability, in quality sport activities; improved health-related behaviours of Pacific islanders which impact on NCD risk factors, focusing on increasing levels of physical activity; and improved attitudes towards and increased inclusion of people with disability in Pacific communities. There is a specific focus on Tonga and Kiribati.

From July 2015 this program will be coordinated by DEAT following administrative changes in Canberra. Our success in gaining support for this program is a further reflection on badminton's growing status and credibility.

MEMBERS AND BA

Our agreed 2010–2014 Strategic Plan is the ongoing framework with a revised and modified approach to be in place for the 2015–2018 period. The fundamental basis of the Plan will not change but it will reflect some new developments in High Performance and Participation to reflect new directions.

We continue to move forward in Membership growth and our challenge to better reflect the size of our sport remains. Constitutional change has been challenging but we will continue to strive in 2015 to ensure we have a Constitution that reflects a progressive organisation incorporating the ASC Mandatory Governance Principles.

NATIONAL OFFICE

Despite a quantum leap in the level of BA activity we have managed to maintain a small office and to contain administrative costs.

Tracey Hallam joined us as Assistant National Coach, Lasse Bundgaard's title was broadened to High Performance Director and National Coach, and Ricky Yu continued his significant coaching work. Daphne Doukas left us for a senior position elsewhere with our best wishes, Ingrid Finnegan has been a significant asset and contributor and Donna Millington continued her excellent work in the finance area. Glenn Warfe has an expanding role in Junior Development assisted by Stuart Brehaut, and Rudy Bartholomeusz guides CALD, Coach Education.



WEBSITE/SOCIAL MEDIA

The Super Series was a key driver in the development of a new Events website. BA continues to try and improve our home site noting there remains room for improvement and we also face the challenge of needing to do more in the public relations area overall—perhaps in 2015.

COOK ISLANDS

EVENTS

Our Event strategy continues to be our key strategy to lift profile, build our brand and grow sponsorship—and it is paying dividends. Badminton, as a result primarily of the Super Series Event, has achieved growth in media coverage—the next step is to also achieve longer term legacies relating to growth in player number and improved performance standards. With patience and persistence this will come and be added to if we are successful in our bid for the Sudirman Cup in 2017.

The Super Series compared well with other Super Series Events and the team of organisers and volunteers, led by Loke Poh Wong, are to be congratulated. The 2015 Challenge is to do even better. The Event would not of course be possible without Destination NSW and we are indebted to them for their support. There is more on Events elsewhere in this Report.

Other events during the year are equally as important to reach out to the badminton fraternity. The Junior International in Ballarat, along with the Oceania Championships; the International at Maribyrnong; our events hosted by New Zealand, Tasmania, NSW, WA were all very successfully conducted and BA extends sincere thanks.



INTERNATIONAL ISSUES

Geraldine Brown is one of the Vice Presidents of the BWF and is President of Oceania; Loke Poh Wong is a Board Member of Oceania and sits on the BWF Events Committee and we are very well served by our international officials. We continue to contribute to Oceania activities especially through the Pacific Partnership Program and we will continue to do what we can to encourage badminton growth in the Region. We were sorry to see Corinne Barnard resign as COO of Oceania and wish her well with her new challenges. We welcome Nadia to her new position.

GENERAL ISSUES

BA was represented at meetings of the AOC, ACGA and various workshop seminars organised by the ASC/AIS. We continue to appreciate the support of RMIT, our liaison with ASADA who serviced our Super Series testing and we met regularly with the ASC on developments and obligations. We continued dialogue with our insurance providers, explored a range of governance issues with our legal team and looked at new sponsorship avenues. We built excellent relationships with a range of National Organisations in other countries in the hope that we can develop partnership links.

THE FUTURE

Our 2015 goals are:

- finalise our new constitution
- improve our international results by and at the 2018 Commonwealth Games
- expand our participation programs with an emphasis on Shuttle Time, inclusive programs and the disabled
- further build our revenue base so we can become increasingly self supporting
- work with Members to grow our overall Membership numbers and focus on big picture issues to develop our sport nationally
- implement our revised Strategic Plan
- continue to review the By Laws to ensure they reflect the future not the past
- challenge ourselves to implement new initiatives
- continue to improve our two way communication with members and stakeholders. Collectively we need to think and act globally not just locally
- grow our base of coaches and technical officials. Progress needs to be more rapid
- build our media profile
- Work with Oceania to grow activities in the Region

2014 was a year of change for the Kiribati Badminton Federation. With the election of its new Executive and the implementation of various activities in attempting to build a solid foundation for the development of Badminton in Kiribati.

This report will outline the various activities that the Kiribati Badminton Federation undertook or that it was part of for the year 2014.

ADMINISTRATION

The KBF held an EGM on the 11TH May, 2014 at the Betio Sports Complex. As part of the meeting a new Executive was chosen to take Badminton further into the future. As now the Executive stands at:

- Mr Karawa Areieta** *Vice President*
- Mr Rota Onorio** *Secretary*
- Ms Aurane Tongaua** *Treasurer*

Two members of the previous Committee were retained in order to ensure continuity.

RAT (READINESS ASSESSMENT TOOL)

KBF undertook the RAT towards the end of last year and used attending Pacific Games as a benchmark for the assessment of its performance. The Assessment outlined a lot of areas with which KBF would need to improve and as such the results of the assessment will be used as guide in the development of a KBF Strategic Plan.

Whilst the Strategic Plan has yet to be finalized, this will be completed in early 2015.



DEVELOPMENT

Development work for Badminton has been quite slow due to a couple of factors:

- One shared venue
- Very busy senior membership
- Very young and inexperienced younger membership

However, for those that can commit their time to development work have assisted in many ways in trying to develop Badminton.

Utilising their experience a couple of senior players have begun coaching clinics for beginners in the sport. The coaching clinic have been more an informal process with clinics conducted on a needs basis and upon the request of members.

Proper coaching of players and elite is something that is not done on a regular basis and therefore their needs to be a regular part of the KBF Calendar in 2015.

With PSP implementation in the country it would no doubt add to the quality and ability of KBF to deliver more developmental programs in the future at school level and in the community.

SPORTS EDUCATION

As a young sport trying to establish itself as a dominant sport in Kiribati, the experience in management, administration, coaching and officiating is a factor that has to be considered and constantly improved. Lack of experienced administrators and coaches etc hinder the development of Badminton. As such and thanks to the assistance of the Kiribati NOC (KNOC) and the Oceania Sports Education Program (OSEP), Badminton is building on the skills of its seasoned and new membership through training programs offered to assist in this area.

KBF has been attending and sending representatives to KNOC/OSEP trainings such as; Sports in Communities Administrator, Community Coach & Officials and will be part of upcoming trainings in Team Management training and Strength and Conditioning.

With a small portion of Badminton players and volunteers with skill sets to take on leadership roles these trainings are always a blessing for KBF and it will continue to nominate participants to attend trainings that will assist in building its knowledge base.



COMPETITIONS

Whilst sponsorship for competitions in Kiribati is tight, the KBF has managed to continuously find sponsors for badminton events and has held major and small events throughout the year. Competitions conducted include:

- Independence Anniversary Championships conducted in July
- World Teachers Day (Short competition)
- Betio Community Club Inter Club Championships (held every quarter)
- TUC Sports/Kiribati Community Club Inaugural Championships
- Ad-hoc Small Competitions at the Betio Sports Complex



Competition formats used are based on international standards or what is outlined by BWF, however, for short competitions these are based on rules that have been modified to ensure that games are shorter, finish earlier and are also fun.

AWARENESS & PROMOTION

The sport of Badminton is a very new sport to a lot of people in Kiribati and as a result, KBF has been working hard to ensure that more people are exposed to the game of badminton and thus build its developmental work or activities on that.

The KBF continues in its efforts to build on its membership and part of the task includes a lot of promotion work as well as awareness to the general population. In that regard KBF has been one of the key sports involved in the AusAid funded Kiribati Community Club Project (KCC) in Kiribati.

Whilst the KCC Project is embarking on setting up Community based sports clubs around the main island Tarawa, KBF has been with KCC all the way. KBF is constantly involving its membership in the promotion of Badminton at Community level through the KCC Project to ensure that Community Clubs play the sport of Badminton as well besides the major sports of soccer and volleyball.

Since KBF started working with KCC more than one hundred persons have signed on to be part of Badminton either in roles as athletes/players or on an administration level.

The challenge that **KBF** will continue to face will be in maintaining its membership base in various Communities either through lack of interest or through brain drain to other sports that are more team oriented.

Whilst working with the **KCC** Project has been the major focus **KBF** has also been involved in sport promotional activities such as through Olympic Day, UN International Day of Sports and Peace and other opportunities that present itself from time to time.

GOVERNMENT ASSISTANCE

KBF works closely with the Ministry of Women, Youth and Social Affairs in which Sports is a portfolio of. By solidifying a good relationship with Government and adhering to guidelines set out by Government for the conducting of the affairs of Badminton, government assistance can be provided depending on the circumstances.

Government will now continue its support of Badminton by handling its international affiliation fees.



MEETINGS AND WORKSHOPS

The Kiribati Badminton Federation is always represented at meetings and workshops organized by different organisations in the country—either it be for sports development or issues dealing with social issues. As such Badminton contribution to developmental issues in the country is always taken into consideration.

Among the many meetings and workshops attended Badminton gained a lot more insight into operating and utilizing assistances available through many organizations with which it could utilise to assist in either its development or just in the promotion of the event. This enables Badminton to be seen as a sport that can contribute to what is needed either for sport itself or for social causes.

Northern Marianas Badminton Association marks every season with a milestone. In 2014, **NMBA** managed to have not only one, but two significant achievements—bringing Badminton World Federation’s Shuttle Time to Saipan and hosting a tournament between Guam and **CNMI** players.

Over 60 teachers from both the public and private schools on Saipan benefited from the in-depth and innovative yet easy to learn “how to teach badminton” program as no less than Oceania Badminton regional development manager Nadia Bleaken visited the island in May and patiently introduced **CNMI** educators to Shuttle Time.

In August, after competing in Guam in the last two years, it was **NMBA**’s turn to host Guam National Badminton Federation by holding a weekend tournament. Guam fielded seven players in the three-day competition and the visiting team was impressed with how the host organizes tournaments and implements the club system to **NMBA**’s program.

The association’s programs are still focused on youth development, thus it held the 2014 **NMBA** Youth Badminton Summer Camp for two weeks, culminating with a team tournament. Some of the children who joined the camp are now members of the Community Badminton Club, a special group of U18 players **NMBA** is developing and training for future competitions.

NMBA had a steady number of competitions for 2014 with its long-time corporate sponsors supporting the association by hosting signature events. Sun Palace Hotel kicked off the 2014 season with a singles and doubles tournament, while **IT&E**, Tan Holdings, Shirley’s Coffee Shop, and Traders Insurance hosted their respective sponsored competitions.

While it continues to push for the development of badminton in the **CNMI** and encourages people to stay healthy and active through sports, **NMBA** did not forget its social responsibility as the association took part in various community and outreach programs.

Lastly, **NMBA** has initiated talks with the **CNMI** Public School System before the end of the 2014 season to bat for the inclusion of badminton under the Marianas Interscholastic Sports Organization (**MISO**) program. **MISO** holds sports competition (for high school) throughout the school year and adding badminton to

its calendar will ensure the continued growth of the sport in the Commonwealth.

TOURNAMENTS

Northern Marianas Badminton’s season-opening tournament, the Sun Palace Hotel Singles and Doubles Badminton Competition, showcased youth power as young players clinched majority of the championships in both events.

In the **IT&E** Mixed Doubles and Singles Badminton Tournament, there were repeat champions in the A singles with Andreau Galvez and Hannah Choi still ruling their divisions. Other veteran players also stood up to redeem themselves from a so-so performance in the first tournament of the season.

With the young guns and seasoned veterans even after two competitions, it was an open race in the 2014 Shirley’s Coffee Shop Badminton Classic. Fresher legs prevailed in the men’s singles with Ezekiel Macario and Leo Su winning in the B and C classes, respectively, while veteran Ferdie Arago finally defeated Galvez. In the women’s singles, the old reliables had the numbers with Choi, Dianne Franciso, and Roxe Lazaro topping Class A, B, and C.

In the opening week of the 2014 Shirley’s Coffee Shop Badminton Classic, **NMBA** managed to squeeze in three playing days for the 2014 **NMBA-GNBF** Friendly Competition. Saipan missed a sweep of the three events with the husband-and-wife tandem of Guam’s Angelo and Lykki Lin beating Andreau Galvez and Hannah Choi in the mixed doubles. Saipan nearly had a sweep when Ferdie Arago and the pair of Glenn Bultjens and Sam Jones ruled the men’s singles and men’s doubles events.

For its last two tournaments of the season, **NMBA** held the 2014 Tan Holdings Open and the 2014 Traders Insurance Team Tournament. A balance competition was seen in the association’s penultimate tournament, as different pairs prevailed in the doubles competition and neither youth teams nor veteran squads dominated the field. However, in the Traders Insurance team event, powerhouse and many-time champion Saipan Badminton Club lived up to its lofty billing after routing Shirley’s Badminton Club in the finals.

OTHER ACTIVITIES

NMBA through the Badminton World Federation and Oceania Badminton hosted Shuttle Time with Oceania Badminton regional development manager Nadia Bleaken facilitating the two-hour seminar on how to teach badminton to children and youth in a safe and fun environment.

Private and public school teachers were provided with video footages of actual games and explanation on basic rules and demonstrations on skills, movements, and techniques throughout the session.

At the conclusion of the seminar, participants were upbeat and vowed to share what they learned to their students.

NMBA also held its annual camp with over 100 individuals in the 7 to 18 age group participating in the two-week event. Community Badminton Club led the camp, which ended with a mini tournament. Blue Racketeers won the team competition, while Frederick Guintu and Renee Kise topped the U18 doubles event.

Badminton New Zealand is excited to report back on a fantastic 2014 that saw many new achievements for badminton in our country. From participation to performance, administration to coaching, Badminton New Zealand has striven to deliver enhanced value back to the New Zealand badminton community through a range of services. Although 2014 has seen significant progress across a number of areas, continued work is required to build capacity and capability at all levels. Badminton New Zealand would like to recognize the work and contribution of our key stakeholders, especially our member associations, Badminton Oceania, the Badminton World Federation and Sport New Zealand.

Key Highlights in 2014 include:

- Implementation of the new Shuttle Time programme that saw 42,423 children participate and engage in badminton. This is a 244% increase from the 12,346 children reported in 2013 that participated in the Racqueteers programme.
- The SkyCity New Zealand Badminton Open was successfully delivered with 242 players from 16 countries. The finals were televised live in NZ and into several countries in Asia, with a reach of 29 million households. This event has been upgraded to a Grand Prix Gold for 2015.
- Investment from Sport New Zealand to Badminton New Zealand grew from \$115,000 in 2012/2013 to \$196,000 in 2013/14 (an increase of 70% or \$81,000). This is the fourth largest percentage increase for any of the National Sports Organisation (NSO) funded by Sport NZ. Badminton New Zealand has moved ahead of five sports to be placed 25TH on the Sport New Zealand NSO Investment list (30TH in 2014).
- Delivery of the Badminton New Zealand Junior High Performance Programme—a planned and executed initiative to support young high performance players and provide a pathway for Association coaches. 112 players accessed the Badminton New Zealand Talent Development Programme, the New Zealand Olympic Committee Solidarity Programme or the New Zealand National Age Group Squads, this is a 600% increase from 2013.
- Oliver Leydon-Davis and Susannah Leydon-Davis won the 2014 Oceania Mixed Doubles title in Ballarat, Australia.



- The New Zealand Badminton Team competed at the 2014 Commonwealth Games, placed 9TH in the team competition and Anna Rankin and Michelle Chan achieved the best results for individual players in reaching the quarter finals stages of the individual competition.
- Establishment of the new South Island Development Coordinator and Operations Coordinator positions with Badminton New Zealand. These important roles provide Badminton New Zealand with much needed additional capacity to make a bigger impact in working with our badminton community.
- Badminton New Zealand Technical Officials continue to be well represented nationally and internationally. Technical Officials from New Zealand officiated at the 2014 Commonwealth Games and at a range of high profile international events as well as gaining BWF and Oceania qualifications.
- Successful staging of the X-TRM Australasian U17 Championships at Auckland, with Northern NZ winning the team title and Oscar Guo (North Harbour) winning the Boys Singles while still qualifying for the U15 Age group.
- Growth in our connection and engagement with commercial partners including the introduction of Honda, STA Travel, One Pure and the extended the partnership with X-TRM.
- Restructured the event management of New Zealand national badminton events to create greater control and quality assurance in their delivery and leverage.
- Successful in accessing NZOC Olympic Solidarity Funding in 2014 and 2015 that will see continued international best practice accessed by the New Zealand badminton community.



- Partnered with Badminton Oceania and the BWF to deliver Shuttle Time Tutor courses and BWF Level 1 Coach Education opportunities for the first time in NZ. 321 coaches participated in development/training opportunities (through Shuttle Time, Badminton New Zealand Coach and BWF Level 1 coaching qualifications) in 2014, a 172% increase.
- Successful in the bid process for badminton to be selected as a sport for the 2017 World Masters Games.
- Badminton New Zealand reached 6,794 Facebook likes with a social media engagement of over 102,000 people.
- Launch of the Girls in Badminton research project. In summary it saw 259 participant hours, 115 girls surveyed, 98 girls involved in the creation of the project, and 86 participated in program delivery.



Five schools and churches involved and three pilots across NZ in Christchurch, Wellington & Auckland.

- 5 Associations complete an ODT or WOF Tool to assess their capability and effectiveness. Specific strategy sessions and work was completed with Associations in need of specialised support in 2014. Badminton New Zealand has also launched the DELTA series of professional development opportunities and resources specifically designed for Associations.
- Completed the Independent Review Community Consultation Roadshow with 9 workshops held around New Zealand. This important piece of work for the future of badminton in New Zealand is on track with recommendations scheduled to be presented back to stakeholders and Associations in February 2015.

A tremendous amount of work goes into achieving these key results and it is important to recognise the Board of Badminton New Zealand, the Staff of Badminton New Zealand, our key volunteers and convenors, our 25 member Associations and the wider badminton community. As we head into another busy year in 2015 we look forward to working with our stakeholders and partners to continue to grow and develop badminton in New Zealand.

TAHITI



1. SHUTTLE TIME

Shuttle Time is still a great success in Tahiti with many primary and secondary schools being approached, and benefiting from badminton initiation sessions.

2. CLUBS

Numbers of kids is still growing. We have 3 training a week for kids from 9 to 18. In BUCPF around 60 kids taking part to these weekly training session.

Arue is also growing, with now 2 weekly sessions, compare to only one last season.

We also have 2 new clubs in Tahiti around Taravao, and one new club in the Marqueses Islands. Each club received a starter kit with rackets, nets and shuttles.

3. HOLIDAY CAMPS

Every holiday, we still put up a camp for 9 to 18 years old, with different level. The average number of participants to those camps is 15.



4. NATIONAL SQUAD

Our seniors prepared really seriously the Oceanias champs. For the first time we trained 5 times a week for 5 months, with also a 15 days training camp during Christmas holidays.

Following this lead, our juniors are training hard for Oceanias Juniors in February since April. We started with one training (physical) a week with 25 kids until July. Then from August to October 3 training a week with 16 kids, and since October we have 4 training a week with 8 kids.



5. TOURNAMENTS AND OTHER

We still have around one tournament per month for juniors and seniors.

We also had an open day around Taravao in October, where everyone could come and try badminton.

We are planning to do another open day for PE teachers, to link up with school kids and make these kids join our monthly tournament.

6. PRESS

This year we had a lot of coverage. Many articles in the press, internet, and TV coverage for every tournament. We also had a 20 minute documentary about our senior squad shown twice on TV.

1. INTRODUCTION


This is a brief annual report from the Tonga National Badminton Association (TNBA), covering the period of January–December 2014. The highlights of accomplishments and events of the year for TNBA were as follows:

- Approval and implementation of the Pacific Partnership Program (PSP) with Badminton Oceania.
- Unexpected and tragic loss of our PSP coordinator, Mrs Ahosivi Kaitapu on 7 October 2014.
- Continued participation to the Pacific Player Development Program (PPDP)
- Participation of 2 TNBA Members on 2014 BO's Annual General Meeting, held in Ballarat, Australia on 15 February 2014.
- Participation of one representative to BWF Annual General Meeting held on 22 May 2014 at Le Meridien Hotel, New Delhi, India.
- OSEP Training by Sainimili Talatoka and Nadia Bleaken.
- Shuttle Time inter-school and local club competitions.
- PSP workshop and Sport Matters Conference.

Following is a summary of important accomplishments and events for the year 2014.

2.1 THE PSP PROGRAMME

The contract for the PSP Programme between BO and TNBA was signed on 26 March 2014. Active work started from this period with 2 casual workers employed as PSP Coordinator and Development Officer, for a start. By July 2014, these two positions were regularized to a permanent contract for the 2 PSP staff. Unfortunately, we lost our PSP Coordinator, Mrs Ahosivi N Kaitapu, with her unexpected and sudden

passing away on 7 October 2014. She is greatly missed by the TNBA Community and our heartfelt condolence goes to her family.

The duration of the PSP programme is 4 years. On the first quarter of the operation (April–June 2014), highlights of

work done includes database update and compilation of all the Shuttle Time participation by Schools and Clubs that were already established in the previous years. Status report was then prepared and submitted to the BO's Chief Operating Officer. Also part of the work done during the June quarter includes the preparation of the Activity Plan and Budget until the end of June 2014 as well as the formulation and submission of the TNBA's Child Safe Sporting and Development Policy in March 2014. This policy is a prerequisite from the Australian Government for all the PSP recipients.

For the first quarter of FY 2014–2015 (July–September 2014), some of the major accomplishments include the permanent recruitment of PSP Coordinator, Mrs. Ahosivi Kaitapu, and Development Officer, Mr. Lauti Naaniumotu. The number of School Clubs who participated in the Shuttle Time had increased as a result of the activities organized and implemented during the quarter. The aim is to continue and increase the number of children playing Badminton and contribute in reducing the risk of obesity for these school children. The full PSP report for this quarter was submitted to the COO.

The activities for the quarter of October to December slowed down for 2 major reasons: first, our PSP Coordinator, Mrs Ahosivi Kaitapu, unexpectedly passed away, and second, the budget required for this period was not released on time and hence, some of the planned activities were delayed.

2.2 THE PACIFIC PLAYER DEVELOPMENT PROGRAMME (PPDP)

For the year 2014, three PPDP Camps were attended by TNBA Athletes. Tonga is one of the Pacific countries who was selected to continue on with the Phase 2, 3 and 4 of the PPDP Programme.

PPDP Phase 2

It was held in Ballarat, Victoria, Australia on 10–21 February 2014. This was successfully completed with 6 Athletes and a Coach from Tonga under the Program. The PPDP Phase 2, a combined coaching, training and event participation, was also completed with full participation from the Tongan Team to the Oceania Championships and Australian International Junior Championships, held on 10–15 February 2014 and 20–22 February 2014 respectively. There were a total of



6 countries who participated in the Oceania Champs (Australia, New Zealand, New Caledonia, Tahiti, Tonga and Nauru) and 5 countries for the Australian International Junior Champs (Australia, Tahiti, Malaysia, Indonesia and Tonga).

Although no medals were won by the Tongan Team, the full training and participation to the events, experience and exposure was definitely invaluable to the future development of players and Badminton Development in Tonga. A Sportsmanship Award was given to one of the Tongan Athlete, Lauti Naaniumotu during the above competition.

PPDP Phase 3

It was held in Auckland, New Zealand on 10–28 April 2014. This development program is a combined program for Tonga, Tahiti and New Caledonian Team, total of 16 participants, representing Team Oceania for the SkyCity New Zealand Open Tournament and the June Bevan U17 Tournament. TNBA was represented with a total of 6 athletes. They were Sione Vainikolo as Coach, Player, & Umpire, with players Renaey Naaniumotu, Litea Tatafu, and Metuisela Vainikolo.

This Phase 3 was also in conjunction with training on BWF Level 1 Coaching for the Pacific athletes. At the end of BWF Level 1 Coaching they were able to



learn more on Coaching skills and the importance of planning for an effective and successful session. Not only that but by participating in the NZ Open and the JB U17 Tournament, everyone was able to learn and understand more. This has made us improve our level of game. BWF Level 1 Coaching making everyone a better coach, photos below on some of the sessions. Tournament Participation and Training has improved Team Oceania in every aspect of being an athlete. They have gained valuable experience and knowledge in training for a tournament, preparing for games in a tournament, playing in matches in a tournament and after the games in the tournament.

PPDP Phase 4



It was also held in Auckland, New Zealand on 10–22 September 2014 with the 2014 Fernbaby Auckland International Badminton Tournament, in conjunction with the continuation of the International BWF Level 1 Coach Education Training on 19–22 September 2014. Only 2 participants from Tonga were represented under this Program, Sione Vainikolo as an athlete and also a participant for the BWF Level 1 Coach Education Programme, as well as Metuisela Talakai Vainikolo as an athlete for the tournament. Sione has completed successfully the programme and now accredited as BWF Level 1 Coach.

2.3 OCEANIA SPORT EDUCATION PROGRAMME (OSEP) TRAINING COURSE

On the 2ND of August the OSEP Coordinator, Sainimili Talatoka and the then Oceania Badminton Development Manager, Nadia Bleaken, visited Tonga for the OSEP Training course. They organized and facilitated training on the PSP partnership and the OSEP Sport in Community Administrators with Tonga OSEP Educators—Salote Sisifa, Uanita



Kaumatule, Sione Likiliki, Lui Muavisi, Iasinito Hausia, Lauti Na'aniumotu along with its Master Educator, Etoni Tonga. The OSEP sica (Sport in Community Administrators) course was conducted to nearly all the Tongan National Sports Federations and Associations on Thursday, 7TH of August with Module 3: "Organising and Staging of an Event". This was conducted by the OSEP educators—Sione Likiliki and Uanita Kaumatule. On Friday, 8TH of August 2014, Module 1: "Understanding of the need of/for an Organisation" was conducted by Lauti Na'aniumotu and Salote Sisifa. Module 2: "Forming a New Club and Club Organisation" was conducted by Sainimili Talatoka with assistance from the rest of the remaining educators—Lui Muavisi, Iasinito Hausia and the Master Educator, Etoni Tonga. The session on Sports Partnership as is with the Pacific Sports Partnership was conducted by the Oceania Regional Development Manager, Nadia Bleaken, using Badminton as a case study. This session is a collaborative efforts of all the Sports Federations and Associations, assisting one another on a ground level to achieve a common goal for the development of each respective sport.

2.4 BO AND BWF AGM AND MEMBERS FORUM MEETING



Representation by 2 TNBA Members on BO's AGM, held on 15 February 2014, Ballarat, Australia. Dr. Amanaki Fakakovikaetau (TNBA Vice President) and Mrs. Leody C Vainikolo (TNBA President and Oceania Board Member) were able to attend the AGM Meeting. Leody also attended the BWF AGM, held in New Delhi India on 22–23 May 2014, thanks to subsidy to these meetings.

2.6 SHUTTLE TIME, INTER-SCHOOL COMPETITIONS AND LOCAL CLUB'S OPEN TOURNAMENT

In the past years, only local open tournament is held annually but with the PSP/Shuttle Time Programme implementation, many inter-school and inter-club tournaments were organised. These were held from the period of July–October. This photo was taken at the conclusion of the competition on 4 October 2014.



2.7 PSP WORKSHOP AND SPORT MATTERS CONFERENCE

The TNBA President, Mrs Leody C Vainikolo, had an opportunity to attend a one day PSP Workshop on 28 September, together with Miss Nadia Bleaken, then Regional Development Manager, now COO. This workshop provided an opportunity for TNBA representative to learn more about the other Oceania Sports Federations funded under Phase 1 and Phase 2 of the PSP Programme. Presentations from the Programme Managers/representatives of the various sports federations were invaluable, sharing good practice, lessons learned, and challenges on the implementation of their PSP's. A very good opportunity as well to meet the PSP staff particularly Nick Cassidy and Ed McCowan who also presented an update about the transition to the new PSP Management.

The Sport Matters Conference on 29 September to 1 October, held at University of Queensland and Brisbane Convention Center was also attended by Leody and Nadia and this is another opportunity of learning and inspiration from the presentations and from notable guests invited during the conference.

Insights on various presentations includes behaviour change through sport, cross-cultural communication, disability inclusion, monitoring and evaluation, economic development, safeguarding children, athletes as role models, and gender-based violence. BO and ASC is acknowledged on e above workshop and conference attendance.

3. MAJOR PLAN IN THE FUTURE

- To continue the implementation of the PSP Programme with the recruitment of the new PSP Coordinator the soonest possible. Particular attention will be given to completion of all quarterly reports on its new format and submission in due time.
- To continue and focus on PPDP and local Player Development and capitalize on lessons learned from the previous 4 PPDP Development Camps. Refocus on pathways for our athletes and set the target for major events for participation.
- Focus on building up the TNBA Capacity.





1. STATEMENT OF GENERAL ACCOUNTING POLICIES

REPORTING ENTITY

Badminton Oceania Confederation Inc is incorporated under the Incorporated Societies Act 1908 and is subject to the provisions of the Act.

The financial statements of the Confederation have been prepared in accordance with generally accepted accounting practice in New Zealand (NZ GAAP) and other applicable financial reporting standards as appropriate for public entities that qualify for, and apply, differential reporting concessions.

MEASUREMENT BASE

The accounting principles recognised as appropriate for the measurement and reporting of financial performance and financial position on a historical cost basis are followed in these financial statements.

SPECIFIC ACCOUNTING POLICIES

The following specific accounting policies which materially affect the measurement of financial performance and financial position have been applied:-

Property, Plant and Equipment

Property, plant and equipment are recorded at cost less accumulated depreciation.

Grants

Grants received are recognised in operating revenue, unless specific conditions attach to a grant and repayment of the grant is required where these conditions are not met. In these cases, the grant is treated as a liability until the conditions are met.

Accounts Receivable

Accounts Receivable are stated at their estimated realisable value.

Foreign Currency

Transactions in foreign currencies are converted at the appropriate New Zealand rate of exchange ruling at the date of the transaction.

Depreciation

Depreciation has been calculated to allocate the cost or valuation of assets over their estimated useful lives, at the following rates: -

Income Tax

The Confederation is exempt from income tax in terms of section CW46 of the Income Tax Act 2007, as a body promoting amateur games or sports.

Goods and Services Tax (GST)

These statements are prepared on a GST exclusive basis, except for Accounts Receivable and Accounts Payable which are inclusive of GST.

Employee Entitlements

Provision has been made for the Confederation's liability for annual leave. The annual leave provision has been calculated on an actual accumulated entitlement basis at current rates of pay. This equates to the cash amount necessary to settle the obligation as at balance date.

Differential Reporting

The entity is not publicly accountable and is not large under defined criteria. It therefore qualifies for differential reporting in respect of accounting standards, and all appropriate exemptions have been applied, with the exception that a Statement of Cashflows has been prepared.

CHANGES IN ACCOUNTING POLICIES

There have been no changes in accounting policies. All policies have been applied on bases consistent with those used in the prior year.
