Joined the Board of Badminton Victoria (BV) in 2002 holding to the post of Treasurer for four years and was elected President in 2006. Was also elected to the Badminton Australia (BA) Board in the same year and retired as BV President in 2010 following the change of constitution. Was elected to the Executive Badminton Oceania Confederation (BOC) in 2009. Key portfolio held with BA and BOC is with the hosting and organising of major events. Am currently in the event working group for Badminton World Federation (BWF) with World Senior Championships. Have been the Director in charge of key International tournaments including the ABO held in Australia since 2011.


