Management Reporting

Report received

BWF CC Workshop was held and one of the key outcomes from this was 'Return on Investment'. It is important that any resource we invest has a good return for both BOC and BWF. Investment should be more targeted and looking for a better return on investment (quality not quantity).

Staff Update. The SG spoke to her report regarding a re-organisation of roles under the BWF CCHR programme, all within the same budget for 2023. The SG is currently in discussions with the BWF and will advise when proposed changes are approved

Staff Remuneration policy. NZ economy currently has a high inflation rate; the remuneration policy currently allows for an annual increase in staff wages/contractors fees equal to the annual NZ Consumer Price Index calculated at the end of the calendar year. It was agreed that the annual increase be capped at 5% which is in-line with the CCHR increase we receive from BWF and to allow for increases over and above this based on performance.

8 countries will be attending the Capacity Building Administrators Workshop in December being run by John Shearer – BWF and BOC Staff



OSFO Grant – the original criteria were changed; in discussions with OSFO Julie and Nadia submitted a new application (via email) for USD10,00 which was granted to be used for the coach course, u15 training camp and competition and Oceania Champs in February.

BWF Plans and budget to be submitted by end of November. Julie to have a draft done by mid-November and will circulate an executive summary for feedback

Increased income and therefore associated expenditure due to high USD. There will be significant expenditure between now and the end of December. All income from the BWF has been received.
