

Insurance coverage	Players and all members of the national delegation shall hold valid insurance for damages of any nature caused to third parties. Such insurance shall cover bodily injury, including medical and hospitalisation expenses incurred in the host country, as well as all expenses and costs associated to repatriating the injured party to its country of residence.
Indemnity	To the extent permitted by applicable law, all players and members of the national delegation shall release the BWF, Badminton Oceania, the Tournament Organiser, and their respective officers, officials, employees, agents, and representatives, from any and all liability, damage, loss, cost or expense that such players and members of the national delegation may incur as a result or in connection with their participation to the Tournament.
Participant Agreement for Use of Photographs and Videos	Players and all members of the national delegation shall agree to give the BWF, Badminton Oceania and the Tournament Organiser full picture rights, including permission to film players and members of the national delegation during all matches and activities around the Tournament, for any commercial, news or other purpose together with the right to transfer such right, including without compensation.

2. Entry Details

Regulations (Conditions of Play)	This tournament will be conducted in accordance with, but not limited to, the Badminton World Federation (BWF) Statutes and General Competition Regulations (GCRs) and the Badminton Oceania Grade 3 Tournament Regulations. In the event of any dispute, the decision of the Tournament Referee will be final. Clothing and advertising are in accordance with the BWF General Competition Regulations (sections 20-24). The name of the player is MANDATORY on the back of all the players' shirts. The country name is optional, however if it is on the shirt, it must comply with BWF regulations. Quarterfinals onwards GCR 21 regarding clothing colour will apply:
	 In Singles matches opposing players must wear significantly different coloured clothing.
	In doubles matches both players must wear the same colour clothing and opposing pairs must wear significantly different coloured clothing
Scoring	Best of three games to 21 points, as per the Laws of Badminton (BWF Statute 4.1)

Entry Fees

All players are required to pay entry fees.

The entry fee for international players is USD120.00

The fee for local players is AUD150.00

Member Associations will be invoiced on 02 October 2024 with payment due by 9th Oct 2024. Players will not be given an accreditation pass until the entry fee is paid.

The Member Association that enters a player into the tournament is responsible for paying the entry fees for that player. Entry fees become due if a player is entered and has not been withdrawn by the time the draw is made. Entry fees are due for all players including any who withdraw once the draw is made. Entry fees will not be refunded in the case of a withdrawal.

The entry deadline is Tuesday 10th September 2024 at 23:59, BWF Headquarters time (+08:00 hrs GMT). Late entries will not be accepted.

After the entry deadline, the BWF Online Group Entry System will send notification to all participating Member Associations confirming receipt of final entries. Receipt of this notification is the conclusive evidence of receipt of entries before the deadline.

















Member Associations should contact BWF immediately if such notice is not received by Wednesday 11th September 2024 at 12:00 hrs BWF Headquarters time.

If no objection is received by BWF by Friday 13th September 2024 at 23:59 hrs BWF Headquarters time, the entries shall be deemed to be correct. No complaints/objections will be entertained after this point.

Clothing and Advertising Regulations	Clothing and advertising are in accordance with the BWF General Competition Regulations (sections 19-23). The name of the player is MANDATORY on the back of all the players' shirts. The country name is optional, however if it is on the shirt, it must comply with BWF regulations. Quarter finals onwards GCR 21 regarding clothing colour will apply: In Singles matches opposing players must wear significantly different coloured clothing In doubles matches both players must wear the same colour clothing and opposing pairs must wear significantly different coloured clothing Players should ensure that they read these regulations and that their clothing complies with these regulations.

















Presentation Ceremonies	All prize ceremonies will take place on Sunday 13th October 2024, immediately after the conclusion of each final. Medals/trophies will be presented to all champions and finalists.
	No equipment, including rackets and flags, is allowed to be brought onto the podium. Clothing worn during the ceremony must be in accordance with the BWF GCR.

Medical Services	First aid and a physiotherapist service will be available during the tournament.
Anti-Doping	Doping control in badminton, in accordance with BWF Anti-Doping Regulations, is conducted out- of-competition and in-competition with the collection of urine and/or blood samples.
	Athletes are responsible for any substance found in their body. Before an athlete takes any medication, they should check with their doctor, and if necessary, get a Therapeutic Use Exemption (TUE).

4. Travel & Visa Details

Transport Transport will ONLY be provided to players and officials staying at the official tournament accommodation providers listed in Section 5 below. Transport includes airport pick-ups and airport drop-offs, with daily ground transfer to and from practice and tournament venues and official hotels. Airport Pick-Ups Airport pick-ups will **ONLY** be from Melbourne Tullamarine Airport and will be available between Sunday 6th October 2024 and Tuesday 08th October 2024 inclusive. Players and officials arriving outside these periods will need to organise their own transfer to Bendigo. Please complete and submit the flight details form no later than Friday 27th September 2024. Requests after this date cannot be accepted. Requests for a refund of taxi charges will not be entertained. Please note the travel time between Melbourne Tullamarine Airport and Bendigo by car is about 1.5hr. **Airport Departures** Airport departures will be from official hotels and from the tournament venue. Airport departures will ONLY be available between Sunday 13th October 2024 and Monday 14th October 2024 inclusive. Those staying in the official hotels who wish to leave Bendigo early can request for drop off at the Bendigo Train & Bus stations. Departure flight details must be confirmed at least two (2) days in advance to the Tournament organisers. **Visas** If a visa is required to enter Australia, please complete and return the Visa Request Form attached as soon as possible. The tournament host and hosting Member Association accepts no responsibility for withdrawals made due to late or refused visa applications.
