

Dates: Men's & Women's Team Championships: 10 - 12 February

Individual Championships: 13 - 16 February

Eligibility:

As per BWF General Competition Regulations 6.1 – International Representation All players representing a MA <u>must hold a passport</u> of the country they are representing or, have held a BWF number of the Oceania MA they are representing, for a <u>minimum of 3 years preceding</u> the Championships.

Regulations:

The tournament will be governed by the Oceania Mixed Team Championships and the Oceania Championships regulations, which are both available on the BOC <u>website</u>

The prospectus for the individual Championships and all forms for both the team competition and individual Championships will be distributed no later than 10 November 2024

Team Format:

Team ties are 5 matches: (1 X MS/WS/MD/WD/XD) – a player may play in a maximum of two matches per tie

Team List

Each Member shall nominate a Team List to BOC through the on-line system, from who its team will be selected for a tie, within the stipulated time as per section 10 in the Oceania Mixed Team Regulations, no later than Monday 27th January 2025 23:59 GMT+8

A team shall constitute of a minimum of two male and two female, and a maximum of six male and six female players

Sudirman Cup Finals:

The winner of the Oceania Mixed Team Championships will qualify to represent Oceania at the TOTALENERGIES BWF Sudirman Cup Finals in China, April 2025.

BOC will provide a travel subsidy to the winning Oceania Championships team of NZD5,000 to attend the BWF finals. This subsidy is not payable if the team does not play in the BWF Finals. If the winning team chooses not to play in the Finals, the second placed team will be offered the position. The team who attends the Finals will receive the subsidy.

Withdrawal

Teams withdrawing within 6 weeks of the tournament will be charged a withdrawal fee of USD750

Transport

Airport transfers and transport between the accommodation venue/s and the tournament venue will be provided at no charge for those teams/players staying at the official tournament accommodation

Teams may be provided with a self-drive mini-van for both the team and individual events. Drivers must hold a current driver's license and be over 25 years of age.

The transport form for the Team Event must be received no later than Monday 20 January

The transport form for the players only playing the Individual events must be received no later than Wednesday 22 January

No transport requests made after these dates will be accepted

Travel

The closest international airport is Auckland.

All travel, visas and travel insurance will be the responsibility of the MA.

Insurance

It is recommended that players and all members of the delegation have travel insurance Participants are recommended to bring sufficient funds to cover any medical expenses

Visas

If a visa support letter is required please complete the Visa Request Form no later than 14 January 2025

Please be aware that visas may take several weeks to be granted, it is highly recommended you apply as early as possible.

Badminton Oceania will only communicate with the Member Association, and will only provide a visa letter of support if the form is completed accurately. It is the responsibility of the Member Association or individual to apply for the necessary visas in sufficient time. All questions regarding visas should be directed to the Embassy/Visa Application Centre in charge.

Indemnity

To the extent permitted by applicable law, all players and members of the national delegation shall release Badminton Oceania Confederation and the Host Organiser (Badminton North Harbour), and their respective officers, officials, employees and representatives, from any and all liability, damage, loss, cost or expense that such players and members of the national delegation may incur as a result or in connection with their participation in the tournament.

Clothing and Advertising Regulations

This tournament will enforce the clothing and advertising regulations as per the BWF GCR 20-24

For the Mixed Team competition: as per the <u>BOC Regulations</u> each player in the team must wear the same colour of shirts and shorts

Country name is MANDATORY

Each team should ideally have two significantly different coloured sets of clothing

For the individual Championships the Player Name is MANDATORY

Anti-doping

Doping control in badminton, in accordance with <u>BWF Anti-Doping Regulations</u>, is conducted out-of-competition and in-competition with the collection of urine and/or blood samples. Athletes are responsible for any substance found in their body. Before an athlete takes any medication, they should check with their doctor, and if necessary, get a Therapeutic Use Exemption (TUE). Badminton Integrity

<u>Section 2.4 of the BWF Statutes (Code on The Prevention of The Manipulation of Competitions)</u> relates to anti-corruption and anti-match manipulation, and this code applies to all participants at this tournament.

To protect the integrity of BWF sanctioned tournaments, participants are not allowed to bet in any way on badminton matches, respect the principle of fair play, and shall not attempt to influence the course or result of a game or match.

Every person has an obligation to report to the BWF any approaches by anyone to gather inside information or to change the outcome of a match.
