Management Reporting – Finances

Financial Report received.

The budget for 2025 will be set using a likely USD rate of 0.65 as the dollar appears to be relatively stable

Grant structure from the BWF is changing and this will allow us more flexibility and control over where we allocate the funding. Awaiting finalised details from BWF on this. GB advised that in future funding may be withheld if gender balance (minimum 40%) is not met for an activity or programme.

BOC Risk Register

A new format for the BOC Risk Register was presented and approved. Recommendations for amendments to the register were as presented by the SG

Items to be added to the Risk Register were agreed as follows:

Events – Grade 3 – Sanctioned by BOC. Cancellation or poor delivery is a reputational risk to BOC Events – Oceania Championships - Cancellation due venue issues or any other factor – financial risk

Constitution – If changes to the constitution are not filed and approved by April 2026 then BOC would no longer exist as an entity as the NZ law

It was agreed that the above two risks would be added to the Risk Register, the Secretary General to finalise appropriate wording /risk consequence and circulate.

Constitution Update

The Constitution is being revised by the office staff. Once this is finalised, it is recommended that this is passed to a Lawyer who specialises in this area for review.

Agreed to align with the BWF constitution with regards to process to be followed if the VP resigns midterm.

This is a matter of high urgency as the intent is to have the Constitution ready for presentation to the AGM in April 2025.

Executive Board Composition

At the next AGM, there will be two vacancies on the EB for nomination/appointment. This is the current unfilled EB position, and the position left vacant by the resignation of Geraldine Brown. The appointments for the two EB vacancies will be for one year.

Report on BWF Meetings

Geraldine Brown has sent notes on the BWF meetings to the President and Secretary General. Many of the points noted have now been confirmed by the BWF and these will be distributed to the EB.

BWF Alignment Workshop

Loke Poh Wong gave a brief update on the BWF Alignment workshop held with the BWF. This was attended by Julie Carrel, Loke Poh Wong and Geraldine Brown.

It was felt that many of the ideas from the workshop were the BWF 'testing the waters' with regards to potential BWF/Confederation alignments in the future

Presentation of the draft Strategic Plan

The BOC staff have produced the draft Strategic Plan for 2025 – 2028 as per the instructions from the Executive Board, this has been sent to the EB. Thanks was given to Julie and the staff for this work.

The Strategic Plan is the framework for the next four years and under this will fall annual / operational plans which will contain the detail

The EB is to look over the strategic plan and reply to the Secretary General by Friday 22nd November to confirm that they have read and if they have any comments / suggestions / queries.

BOC AGM

To be held on Thursday 24th April 2025 in Xiamen, China.





BOC Office will product an information sheet for our members regarding how the BWF funding and arrangements work, to include information about what their responsibilities are, what they need to attend, what they may need to pay for – ie. meals etc

As agreed at the previous EB Meeting, the AGM will not be a hybrid – it will be an in-person meeting only. MA's are to be reminded that, in order to receive a BWF MA Grant, they must attend an AGM (Continental or BWF) at least one every two years.

Next Meeting – last week of January /first week of February 2025 – date to be confirmed.

Loke Poh Wong thanked Geraldine Brown for her years of service to Badminton Oceania following her resignation from the Executive Board.
