

Dates: Mixed Team Championships: 8 – 10 June

Individual Championships: 12 - 15 June

Where: Saipan, Northern Mariana Islands

Eligibility:

As per BWF General Competition Regulations 6.1 – International Representation All players representing a MA <u>must hold a passport</u> of the country they are representing or, have held a BWF number of the Oceania MA they are representing, for a <u>minimum of 3 years preceding</u> the Championships.

Regulations:

The tournament will be governed by the Oceania Junior Mixed Team Championships and the Oceania Championships regulations, which are both available on the BOC <u>website</u>

The prospectus for the individual Championships and all forms for both the team competition and individual Championships will be distributed no later than Friday 14 March 2025

Team Format:

The Oceania Junior Mixed Team Championships will be played as a Team Relay as per the regulations

Each tie will consist of 10 matches:

- Two Men's Singles
- Two Woman's Singles
- Two Men's Doubles
- Two Women's Doubles
- Two Mixed Doubles

Team Entry

Team entry closes 25 March 2025 through the BWF on-line system

Entry Fees: - NZD\$250 per team - Team Championships

Team List

Each Member shall nominate a Team List to BOC through the on-line system, from who its team will be selected for a tie, no later than <u>Friday 23 May 2025 23:59 GMT+8</u>

A team shall constitute of a minimum of two male and two female, and a maximum of twelve players in total. All players must meet the eligibility criteria as per Regulations 5.1 - 5.3

- NZD\$250 per team Team Championships
- NZD\$150 per player Individual Championships (includes a tournament shirt)

Withdrawal

Teams withdrawing within 6 weeks of the tournament will be charged a withdrawal fee of USD750

The last date for withdrawal without penalty for the Individual Championships is Monday 2 June 2025, any withdrawal after this date will incur a penalty of USD250

Accommodation:

The official hotel is <u>The Crowne Plaza Saipan</u>
Further details regarding the accommodation will be advised no later than 14 March 2025,

Transport

Airport transfers and transport between The Crowne Plaza and the practice and tournament venues will be provided at no charge for those teams/players staying at The Crowne Plaza

Travel details MUST BE submitted on the <u>official form</u> to Badminton Oceania no later than Friday 23 May 2025

Travel

Teams should arrive at and depart from Saipan International Airport All travel, visas and travel insurance will be the responsibility of the MA.

Insurance

It is recommended that players and all members of the delegation have travel insurance Participants are recommended to bring sufficient funds (USD) to cover any medical expenses (the local currency in Saipan is USD)

Visas

The Northern Mariana Islands are a USA territory therefore anyone coming to the Northern Mariana Islands must meet USA requirements.

U.S.A VISA APPLICATION PROCESS

- 1. Players and officials whose country are not under the visa waiver program, visit https://travel.state.gov/content/travel/en/us-visas.html to apply for United States visa.
- 2. Choose Non-Immigrant Visa, B-1.
- 3. Fill out form and submit requirements.
 Set up appointment for interview and pay fee.

If your country is under the Visa Waiver Programme, you need to apply for an ESTA.

Indemnity

To the extent permitted by applicable law, all players and members of the national delegation shall release Badminton Oceania Confederation and the Host Organiser (Northern Marianas Badminton Association), and their respective officers, officials, employees and representatives, from any and all liability, damage, loss, cost or expense that such players and members of the national delegation may incur as a result or in connection with their participation in the tournament.

Clothing and Advertising Regulations

This tournament will enforce the clothing and advertising regulations as per the <u>BWF GCRS 20-24</u>

For the Mixed Team competition: as per the <u>BOC Regulations</u> each player in the team must wear the same colour of shirts and shorts

Country name is MANDATORY

Each team should ideally have two significantly different coloured sets of clothing

For the individual Championships the Player Name is MANDATORY

Anti-doping

Doping control in badminton, in accordance with <u>BWF Anti-Doping Regulations</u>, is conducted out-of-competition and in-competition with the collection of urine and/or blood samples. Athletes are responsible for any substance found in their body. Before an athlete takes any medication, they should check with their doctor, and if necessary, get a Therapeutic Use Exemption (TUE). Badminton Integrity

<u>Section 2.4 of the BWF Statutes (Code on The Prevention of The Manipulation of Competitions)</u> relates to anti-corruption and anti-match manipulation, and this code applies to all participants at this tournament.

To protect the integrity of BWF sanctioned tournaments, participants are not allowed to bet in any way on badminton matches, respect the principle of fair play, and shall not attempt to influence the course or result of a game or match.

Every person has an obligation to report to the BWF any approaches by anyone to gather inside information or to change the outcome of a match.
