In the event of any dispute, the decision of the Tournament Referee will be final.</p> <p>Clothing and advertising are in accordance with the BWF General Competition Regulations (sections 20-24). The name of the player is MANDATORY on the back of all the players’ shirts. The country name is optional, however if it is on the shirt, it must comply with BWF regulations. Presentation Ceremonies	<p>All prize ceremonies will take place on Sunday 10 August immediately after the conclusion of each final. 3. Travel & Visa Details

Transport

Transport will ONLY be provided to players and officials staying at the official tournament accommodation provider – The Crowne Plaza

Transport includes airport pick-up and drop-off, to and from practice and the tournament venue.

Airport transfers will be provided from Saipan International Airport to the CROWNE PLAZA HOTEL upon request. Please complete and submit the flight details form no later than **Friday 25 July 2025**. Requests after this date cannot be accepted. Requests for a refund of taxi charges will not be entertained.

Departure flight details must be confirmed at least two (2) days in advance to the Tournament Organisers.

Visas

The Northern Mariana Islands are a USA territory therefore anyone coming to the Northern Mariana Islands must meet USA requirements.

U.S.A VISA APPLICATION PROCESS

2. Choose Non-Immigrant Visa, B-1.
3. Fill out form and submit requirements.

Set up appointment for interview and pay fee.
