PRESIDENT'S REPORT

As President of Badminton Oceania, it is both a privilege and a responsibility to serve a region that is as diverse in geography as it is united by a shared passion for badminton.

With 18 Member Associations spread across the vast Pacific, we remain the largest confederation by geography and the smallest by population. Yet it is our resilience, adaptability, and collective commitment that continue to define who we are.

Reflecting on 2025, I am proud of the steady and meaningful progress made across events, development, governance and participation. Despite the logistical, financial and structural challenges unique to our region, Badminton Oceania has continued to chart its own course, one that aligns closely with BWF priorities while responding pragmatically to the needs and realities of our Member Associations.

Governance and Strategic Alignment

Throughout the year, the Executive Board and staff worked collaboratively to implement and embed the 2025–2028 Strategic Plan. This ensured strong alignment with the BWF's long-term vision, while retaining the flexibility required to address regional circumstances.

Strengthening governance structures, improving operational efficiency, and reinforcing transparency and accountability remained core priorities. The continued evolution of our operational framework has enabled us to provide consistent and timely support to players, officials and Member Associations, even as expectations and workloads continue to grow.

At the 2025 BOC Annual General Meeting in Xiamen, held in conjunction with the BWF AGM, we welcomed two new Board members; David Carrington (AUS) and Sandra Low (GUM). Their contributions since being elected have added depth, perspective, and strength to an experienced and committed Board.

We had 11 Member Associations attend our AGM in person in Xiamen with a very positive and collaborative mood amongst the delegates.

Tournaments and Events

Tournaments and events remain a key pillar of our Strategic Plan, serving to inspire participation and development by creating positive competition experiences for all who are involved.

In 2025, Oceania once again demonstrated our capability to deliver high-quality international and regional competitions. The Oceania Championships (Open, Junior and Para), a World Tour tournament, International Challenge tournaments, Para Badminton competitions, and AirBadminton events continued to provide meaningful and structured pathways for athletes across all disciplines and levels.

Strong participation across junior, open and para categories, reflects both the growing interest in badminton and the dedication of our Member Associations, event organisers, volunteers, and technical officials. Beyond competition, these events foster regional collaboration and contribute to raising the profile of badminton in Oceania on the global stage.

International Representation

We continue to take pride in the presence and performance of Oceania players, Coaches, and Technical Officials on the international stage. Representation at major BWF events, championships, and multi-sport games not only showcases our region's capabilities but also inspires the next generation and reinforces Oceania's contribution to the global badminton family.

Acknowledgements

I extend my sincere appreciation to the Badminton World Federation for their continued support, guidance, and partnership. I am equally grateful to our Member Associations, whose administrators, volunteers, coaches, officials, and players form the backbone of badminton across our region.

My thanks also go to the Executive Board members for their dedication and collegial support, which are essential to the effective governance of this organisation.

I would also like to recognise the leadership and commitment of my Deputy President; Glenn Cox, fellow Board members; Johanna Kou, Merlie Tolentino, Sandra Low and David Carrington and to thank all those who continue to give their time and expertise for the benefit of badminton in Oceania.

I would like to acknowledge the contribution of Ngaoa Ranginui (COK) who resigned from the Executive Board in May due to personal reasons. Ngaoa had been a Board member since 2018, I thank her for her time and contributions.

To our Secretary General; Julie Carrel who works tirelessly for the benefit of Badminton Oceania, leading the team in the office in Auckland. It was with great pleasure to recognise Julie's 10-year anniversary working for Badminton Oceania in April.

Unfortunately, we lost the services of our Administration and Finance Manager; Lynne Nixey who left in May to take up a role with BWF. We will miss Lynne as part of our team and wish her well in her new role. I welcome new staff members during the year; Krystal, Megan and Bella. I acknowledge our staff, based in Auckland and in PNG, who work tirelessly behind the scenes to ensure the smooth delivery of programmes and services

As we conclude 2025, I remain optimistic about the future of badminton in our region. While challenges will always exist, our collective commitment, collaboration, and passion for the sport give me great confidence that Badminton Oceania will continue to grow in strength, relevance, and impact.

SECRETARY GENERAL'S REPORT

2025 was another year of continued development, growth and achievement throughout the region; most notably:

- 101,722 children from 13 countries participated in Shuttle Time sessions – this is an all-time yearly high for the region
- Confirmation in August of Vanuatu as a new member
- 7 players from Australia (5) and New Zealand (2) played in the BWF World Championships
- 5 teams played in the U15 Pacific Invitation Team Challenge
- The first VICTOR Oceania Junior Championships to be played in Saipan, Northern Mariana Islands – 6 countries participated. Northern Marianas Badminton Association provided accommodation to all players and officials as well as outstanding local hospitality
- 6 BWF Grade 3 tournaments in the region: 5 International Challenge, 1 International Series
- The highest number of entries to date in the VICTOR Oceania Para Badminton Championships: 57 players from 5 countries
- The third edition of the YONEX Australia Para Badminton International was played with representation from 12 countries
- The third year of the SATHIO GROUP Australian Open as a BWF World Tour Super 500 tournament
- Australia staged the first AirBadminton national championships with a team going on to play in the Asia Pacific Championships and the BWF AirBadminton World Cup in Sharjah
- Players from 4 countries attended a training camp at Banthongyord Badminton School in Thailand
- The continuation of the Australia/New Zealand Technical Officials development programme: 7 Umpires and 2 Referees officiated at international tournaments within Oceania
- One Referee and one Umpire qualified as BWF Technical Officials
- Implementation of our new Technical Officials Training and Assessment Panel (TAP) replacing the previous BOTO Committee
- Pinakin Godse (AUS) qualified as an International Para Badminton Classifier
- The Team Up Inclusive GymBad programme continued to make a positive impact in PNG including Paralympian Wojtek Czyz visiting to co-deliver para badminton sessions
- Implementation of a regular Special Olympics programme in New Zealand
- 8 BWF Level 1 Coach Courses with 63 newly qualified coaches
- 2 Pacific Foundation Coach Courses held with 18 newly qualified coaches

- 3 people; including our Development Officer Dhanny Oud, attended courses at the newly established BWF Education Hub in Dubai
- 3 Pacific MAs engaged in regular AirBadminton activity
- 11 Member Associations represented in person at the BOC and BWF Annual General Meetings and BWF Members Forum in Xiamen, China
- Paralympian Wojtek Czyz was the guest speaker at the BOC AGM enlightening and inspiring delegates about para sport.
- 2 new Executive Board Members elected: David Carrington (AUS), Sandra Low (GUM)
- Johanna Kou (NCL) awarded The Heather Robson Award in "recognition of outstanding contribution to the promotion and development of badminton in the Oceania Region"

We had some staff changes this year. It was with mixed emotions we farewelled Lynne Nixey as she left to take a newly created role with the BWF as Head of Technical Officials. Lynne had been a valued member of staff for nearly 10 years, always going over and above the requirements of her role. We wish Lynne well in her new role and look forward to working with her. Bella Phokaisopit joined us in May as the Administration and Finance Manager, replacing Lynne. Also in May, Megan Bramley joined us in a newly created role, funded through the BWF CCHR programme, as Event Manager giving us greater capacity to work in partnership with our tournament hosts, oversee our Technical Officials and assist our Pacific MAs to develop their competition structures.

To the BWF for their on-going support and confidence in us to deliver programmes and activities to our members as aligned with the BWF strategy to grow and develop badminton throughout the region.

We are seeing some great development, growth and progress across the region, and this is due to the commitment and hard work of our Member Associations as we work together in alignment and collaboration.

CAPACITY BUILDING

MEMBER CAPACITY BUILDING

12 Member Associations were provided with 2025 BWF MA Grants. These Grants enabled agreed-upon development activities to be delivered throughout Oceania including Shuttle Time, Player Development, Coach Education, local tournaments, and AirBadminton. BWF also provided a New Member Grant to continue the early-stage development of Vanuatu Badminton Association.

BOC developed a Member Association Capacity Building Course (MACBC) which is designed to upskill MA boards/committees with the foundational information they need to successfully manage a national badminton federation in the context of the Pacific Islands. Portions of the course were piloted virtually with two MAs with the course being reviewed by Aaron Alsop- an independent contractor with vast experience in the Pacific sports sector. BOC will deliver the full MACBC for the first time into three MAs in 2026.

In parallel to the BOC AGM in Xiamen, BOC delivered its own Development Forum to the Pacific Island MAs. This Forum provided an overview of how MAs can identify growth potential through the BWF MA Structures tool which was co-delivered by John Shearer from BWF. The second half of the forum was an interactive group activity focused on identifying opportunities for a simulated Pacific MA. A Para Badminton roundtable was also facilitated by Wojtek Czyn. This allowed for MAs to consider how they can offer para badminton, with Wojtek providing feedback as a former Para Badminton player and advocate for growing the accessibility of Para Badminton in Oceania.



NEW BWF MEMBER

BOC development staff continued their work from 2024 working alongside Vanuatu Badminton Association to establish them as a member of BWF and therefore Badminton Oceania.

It was with great delight that their membership of BWF was confirmed in August with two players representing Vanuatu at the Oceania Para Badminton Championships and the Australian Para Badminton International in October.



Thank you to the BWF for their continued support through a New Member grant to enable our staff to visit Vanuatu and meet face to face with key Stakeholders as well as deliver both Shuttle Time and Para Badminton programmes.

We have connected with Palau Badminton Association who currently operate as a social group in this small country (population 17,000) in Micronesia; with the aim of becoming a BWF member to enable us to further develop badminton up in this area of our region.



GOVERNANCE – ANNUAL GENERAL MEETING

Our AGM was held in Xiamen, China aligned once again with the BWF Members Forum and AGM. We had 11 member Countries attend with some good networking happening between the MAs.

David Carrington (AUS) and Sandra Low (GUM) were elected onto the Executive Board for one year terms, completing the terms from Geraldine Brown and Nigel Skelt who had previously resigned.

Following the formal part of the AGM the Heather Robson award for "recognition of outstanding contribution to the promotion and development of badminton in the Oceania region" was awarded and presented to Johanna Kou (NCL). Johanna was

first elected Secretary of Ligue de Badminton de Nouvelle Calédonie (LBaNC) in 2004, then President in 2018 a position she still holds today. Johanna is well known in the region as a player, winning multiple medals at Pacific Games. She is now very involved as the head coach of the Youth team. Johanna has been a member of the BOC Executive Board since 2016. A very committed and passionate volunteer for badminton.

As a lead-in into the Pacific Island Development Forum Paris Paralympian Wojtek Czyz (NZL) captivated the room as he told his story of how he came from a professional football player to a para sport athlete.

SATHIO GROUP Australian Open

2025 proved to be a huge year for our region with 14 tournaments held with increased entries from previous years. Beside our Continental Championships and the five International Challenge tournaments from 2024 being repeated there was an additional International Series tournament: Junior and Para Badminton Continental Championships and a Para Badminton International. This continued growth in the event space gives more opportunities for our Oceania players to compete, gain experience and earn world ranking points.

The year started off with the VICTOR Oceania Mixed Team Championships and Pacific u15 Invitation Team Challenge held at North Harbour, New Zealand. This competition is part of our Player Development programme for the Pacific Islands. Australia had a decisive 5-0 win over New Zealand in the Mixed Team Championships, earning the right to represent Oceania in the TotalEnergies BWF Sudirman Cup Finals 2025. The Individual Championships took place after the team championships with titles shared between Australia and New Zealand; congratulations to Gronya Somerville (AUS) for winning two titles: Women's Doubles and Mixed Doubles.



In June the VICTOR Oceania Junior Championships (Mixed Team and Individual) were held in Northern Mariana Islands for the first time. We had 7 counties represented, the largest number to date. Alongside competitive matches teams experienced wonderful hospitality from the host and took part in activities such as AirBadminton.

We appreciate the support and generosity provided by Northern Marianas Badminton Association to our young players, making their experience one to remember. There was also an additional International Series tournament, Northern Marianas International, in the week following these Championships to give our junior players the opportunity to play another international tournament.



In August we returned to the Northern Marianas for their back-to-back International Challenge tournaments: CROWNE PLAZA Northern Marianas Open and CENTURY INSURANCE Saipan International with large entries from Asia.

October saw the 3-tournament series of International Challenge tournaments, starting with MAXX North Harbour International, followed by ROKETTO Sydney International, then YONEX Bendigo International. Sydney had a record number of entries, for a grade 3 tournament in our region, of 344 players.

In Bendigo we held a world first with the VICTOR Oceania Para Badminton Championships taking place in the same venue at the same time as the YONEX Bendigo International.



Although a feat to coordinate the two events to run simultaneously, there was a great atmosphere and many positives within Bendigo Eaglehawk Badminton venue with fantastic interaction between the able bodied and para-athletes. A busy four weeks of events saw us finish with the biennial YONEX Australian Para Badminton International drawing competitors from 14 different countries.



The SATHIO GROUP Australian Open, a BWF World Tour Super 500 event, took a new place on the calendar being held in November. Temperatures were warmer than when held in June in the previous couple of years and there were some strong showings from up-and-coming Oceania players.

Thank you to VICTOR for their continued sponsorship of our Continental Championships. Special mention to all the tournament organisers, technical officials and volunteers for their efforts in delivering positive and memorable experiences to players, coaches, managers and other stakeholders.

TECHNICAL OFFICIALS

INTRODUCTION OF TAP

After the disestablishment of the Badminton Oceania Technical Officials Committee (BOTOC) at the end of 2024, the Badminton Oceania Training and Assessment Panel (TAP) was established to manage the development and performance of our technical officials in conjunction with the Badminton Oceania Office.

TAP is chaired by Peter Cocker, with each division having their own chair: Peter Cocker (Referees), David Turner (Umpires), and Richard Wong (Line Judges and Pacific). The chairs along with their panels oversee assessments and appraisals, appointments to tournaments, and organise workshops and trainings to further improve the level of our technical officials.

With this change TAP and the office have commenced the updating of our Technical Officials documentation across the board, this will continue in 2026. We are very appreciative of the time that many people give to be a part of our panels to ensure we keep developing high quality Technical Officials.

PACIFIC LEVEL TECHNICAL OFFICIALS

In line with the Northern Marianas Tournaments held in June, Richard Wong assisted by local Pacific Certificated Umpire; Christy Villaflor ran an Umpire course. This consisted of online sessions in the weeks prior and a practical component in the days before the first tournament. The standard of those on the course was high with 5 new umpires receiving Pacific Accredited Umpire status, a great result for the Northern Mariana Islands to have more qualified technical officials.

In the lead up to the Pacific Games 2027, Tahiti has continued to build their workforce. Overseen in-country by Oceania Accredited Umpire Taurea Mara, there has been plenty of training and officiating at local tournaments; following on from the Oceania Championships in February where two umpires gained their Pacific Accredited qualification.

JUNIOR LINE JUDGE AWARD




Seven successful candidates from Northern Mariana Islands were presented with a certificate after they completed a short assessment with both a theory and practical component.

There has been great growth in the Technical Officials space in 2025. An increase in the number of Technical Officials at each level shows the depth within our region. There are opportunities and pathways through to BWF level for all those who aspire to officiate at the highest level.

Thank you to BWF for the support and funding provided for our Technical Officials programmes at all levels from Pacific through to attaining BWF level.

COMMUNICATIONS



2025 marked a big year for communications at Badminton Oceania (BOC), with significant growth across all platforms and expanded media reach throughout the region.

Following the unveiling of our 2025–2028 Strategic Plan, communications remained a key pillar of our organisation. Our primary objectives for this year were to promote players and BOC activities while increasing media coverage and brand recognition across Oceania and beyond.

The position of Communications Officer was filled in February by Krystal Clark, in time for the VICTOR Oceania Championships.

With 14 events held this year across New Zealand, Australia, and Northern Mariana Islands, much of our communications strategy revolved around the promotion of these tournaments.

LIVE STREAMING

Two courts were streamed for the Oceania Championships (Junior and Senior teams and individuals) and Grade 3 International tournaments, along with four courts for the Para Badminton tournaments for a total of 13 tournaments.

In total, there were 347k views on BOC's YouTube Channel, just under 2 million minutes were watched with 6,568 subscribers at year end.

WEBSITE

Live streaming and events-related content accounted for the majority of views on the BOC website in 2025. Over the course of the calendar year, badmintonoceania.org garnered 291,000 individual web page views, from 178,000 individual users. This is continuing the upward trend of website visits year on year.

MEMBER ASSOCIATIONS

11 of our MAs continue to maintain a regular presence on social media, operating professional Facebook pages.

BOC also conducted a media training course for the region's up-and-coming players at the VICTOR Oceania Junior Championships in June. The aim was to equip players with the tools to create a personal brand on social media and to handle interviews effectively.

Further work needs to be done to continue upskilling our MAs communications to create a continued flow of stories for both BOC and wider media usage.



MEDIA

Through targeted distribution to media outlets, our MA activities and regional events were covered by online and offline publications, including Marianas Variety, Tahiti Infos, Guam Pacific Daily News, Olympics.com, BWF, OSFO, Newstalk ZB, Daily Post Vanuatu, Cook Islands News, Tuvalu TV, Courier Post PNG, France Info, Paralympics NZ, FBC News.

E-NEWSLETTER

Eight editions were distributed to our database of over 700 recipients. Performance exceeded industry standards for sports sector newsletters:

- Average open rate: 43.9% (up 9.8% from 2024; industry standard: 41.85%)
- Click-through rate: 4.75% (exceeding industry standard of 2.88%)

LOOKING AHEAD

Building on this momentum, our 2026 priorities include further strengthening Member Association communications capabilities and expanding our video content library to maintain engagement growth.



SHUTTLE TIME



SHUTTLE TIME – BWF SCHOOLS PROGRAMME

In credit to the outstanding efforts of the Shuttle Time workforce throughout Oceania, participation reached an all-time high of 101,722. This is the first time the milestone of 100,000 Shuttle Time participants in a single year has been surpassed and represents a 9% increase on 2024 participation.

While overall workforce development declined in 2025 by 15% from 2024 with 306 Shuttle Time Tutors, Teachers and Youth Leaders trained, there was success in Solomon Islands, Tahiti, and Tonga returning to local Shuttle Time workforce

development after some years. Some of this decrease is due to MAs reaching a level where-by they no longer require additional workforce and are now focusing on quality meaningful delivery.

BOC supported an innovative pilot programme with Northern Marianas Badminton Association with the introduction of a Youth Advisory Group. This empowered 5 youths (aged 15–18 years old) to deliver a self-determined project focused on growing badminton participation. Their main outcome for the year saw them plan and deliver an AirBadminton Jamboree for over 60 participants, many of which were new to badminton.

Tuvalu Badminton through the Australian Aid Team Up Play for Equity Tuvalu grant delivered a girls Shuttle Time programme with the aim of providing a safe place for the girls to learn badminton through Shuttle Time while also hearing from local women's organisations in a sport for development capacity.

BOC also provided Shuttle Time Support Agreements to Cook Islands, Guam, Northern Marianas, and Papua New Guinea to support the work of their Shuttle Time National Coordinators.

HIGHLIGHTS



Shuttle Time participation reached an all-time high of **101,722**



Northern Marianas Youth Advisory Group enabled junior players to take a responsibility in creating innovative ways to grow participation which resulted in an AirBadminton Jamboree.

Former French Paralympic badminton player and current Shuttle Time Trainer Guillaume Gailly delivered a Shuttle Time Tutors course in Tahiti, reinstating their Shuttle Time workforce development.



Tuvalu Badminton delivered a girls Shuttle Time programme through the support of the Australian Aid Team Up's Play for Equity Fund Tuvalu. This enabled TBF to introduce girls to badminton while also inviting guest speakers such as Fatulei, Tuvalu Women for Change Association.

Special Olympics Papua New Guinea competed at the Special Olympics Asia Pacific badminton tournament in Kuala Lumpur. Winning a silver and a bronze medal between the 4 athletes.



AirBadminton continues to serve an important purpose in making badminton accessible to communities with limited facilities. The AirBadminton equipment is well used in community and school visits throughout Oceania, making it a key element of Shuttle Time delivery.

PLAYER DEVELOPMENT

In 2025 the Player Development programme continued to target young athletes with potential to develop into elite badminton players.

TIER ONE

Seven players, three from New Zealand and four from Australia, were part of the TIER 1 programme in Thailand. The programme started in 2024 with an aim of working towards helping players qualify for the Youth Olympic Games (YOG). With a change in the qualifying criteria where-by the age group was changed, the programme pivoted with fewer eligible athletes. While some of the players are still working towards YOG the others are focusing their development on international representation.

The Oceania representative for the TotalEnergies BWF Sudirman Cup Finals played in Xiamen, China, was Australia after winning the Oceania Mixed Team Championships in February. The team was drawn into Group C alongside Japan, Malaysia and France. While the opposition was strong and higher ranked, Australia won matches against Malaysia in the Women's Doubles and France in the Women's singles.

Training and tournament scholarships continued for four targeted players; identified in partnership with the Member Association: Angela Yu (AUS), Shaunna Li (NZL), Edward Lau (NZL) and Jack Yu (AUS). Players continued to train and compete at international tournaments both within and outside of the region. The scholarships were a collaborative approach alongside support from the MAs to give the players more opportunities through higher level training and tournaments.

During the year there were a number of changes in the world rankings with a significant increase for the following players/pairs:

- **Shaunna Li (WS)** From 200 to 124 an increase of 76 places
- **Edward Lau & Shaunna Li (XD)** 109 to 75 an increase of 34 places.
- **Angela Yu (WD) with Gronya Somerville** from 299 to 38 an increase of 261 places

The following players qualified and competed in the TotalEnergies BWF World Championships in Paris in August.

The highlight was the Australian Women's doubles pair, Angela Yu and Gronya Somerville, who won their first-round match against a Thai pair before narrowly losing their second-round match against the eighth-seeded

Japanese pair of Fukushima and Matsumoto.

TIER TWO

The Oceania Junior Championships (OJC) were held in Saipan in June incorporating the Mixed Team Championships. Six teams took part: Australia, Cook Islands, Fiji, New Zealand, Northern Mariana Islands and Tahiti. Australia claimed the title, New Zealand were runners-up, and Northern Mariana Islands taking the bronze medal. This was the first time the Northern Mariana Islands had won a medal at an Oceania Championships, made more notable as it was the first time they had played in this tournament, defeating seasoned campaigners Cook Islands and Tahiti.

Following the OJC the players from the TIER 2 targeted programme were reviewed and two Pacific players continued to be supported in 2025: Lina Tsukagoshi (NMP) and Mike Mi You (TAH). These two players attended a training camp in Thailand at the Banthongyord Badminton School in Thailand in November. These players are working towards the Pacific Games in 2027 and competing in the Oceania Grade 3 circuit following the Games.

TIER THREE

The U15 Invitational Programme took place for the second time since its introduction in 2023. The teams took part in a multi-day training camp with BOC Coaches leading and mentoring the team of BWF Level 1 Coaches. There was a noticeable improvement in the standard of play amongst the teams compared to 2023 as well as newcomers Wallis and Futuna who participated for the first time on the BOC Player Development Programme. Below are the team placings from the U15 Pacific Invitational Team Challenge. We look forward to seeing these players compete in the older age groups in the future.

PLAYER PATHWAY PROGRAMME

This year we launched a Player Pathway Programme (PPP) that was developed for the relevant and suitable contexts of our Pacific MAs. This programme assists the MAs to develop a 3-4 Year player pathway that is relevant to the needs of their own programmes. The first two MAs to complete the PPP were Cook Islands and Northern Mariana Islands as they both continue to improve their player programmes and development moving into the future.

The PPP will continue into 2026 with another 2-3 MAs undertaking the programme to develop their player pathways for the next few years.

COACH EDUCATION



In 2025 we delivered our highest number of BWF Level 1 courses in a year with a total of 8 courses. This was also the first year of the BWF Education Hub; a new initiative which we see great value in.

The BWF Education Hub which operates out of Dubai had its official opening in 2025. The Hub allows Continental Confederations to send candidates onto global courses which are delivered by BWF. In 2025 we had 3 candidates attend 3 different courses. Dhanny Oud undertook training as a BWF Level 1 Tutor as well as a BWF Disability Level 1 Tutor. Oliver Leydon-Davis (NZL) and Louisa Ma (AUS) were the first candidates from the region to take part in the FastTrack course. This course is for ex-international players who are moving into coaching and is a combination of BWF L1 and L2 Coach courses delivered together for high level ex-international players.

The record number of Level 1 Coach courses in 2025 was spread across the region.



The year started off with a Pacific course hosted in Auckland, New Zealand which had candidates from 5 MAs taking part. Courses were also held in Tahiti, Australia, New Zealand and for the first time–Guam. There were a total of 102 coaches who undertook the BWF Level 1 coach training; however only 63 met the requirements to pass.

Two BWF Level 1 Tutors completed their mentorship in 2025. They delivered their second coach course since completing their Level 1 Tutor course and were mentored by an experienced Tutor from the region.

We continued with virtual development sessions in 2025 with new presentations and opening the sessions to BWF qualified Coaches from across the region. Sessions were delivered by a number of presenters including Tracey Hallam (NZL) and Josh Neil (AUS). There was a focus on higher level coaching with topics such as Talent Identification and Coaching Environments. Coaches from 7 MAs took part in the sessions; these will continue in the future tailored to topics important in the region.

Disability Coach modules were delivered in Australia and New Zealand. These courses will help to continue the growth of Para Badminton programmes across the region and upskill coaches to feel more confident when working with athletes with disabilities. With a record number of players at the Oceania Para Badminton Championships 2025 we know there will be a demand for qualified disability coaches who will continue to help drive Para Badminton participation and performance.

The Pacific Coach development programme continued throughout the year. BWF Level 1 Coaches; Danny Simpson (COK) and Nicolas Mouret (TAH) have delivered BOC Pacific Foundation courses to continue to upskill coaches in their own MAs. In February during the U15 Pacific training camp, national junior team coaches from Cook Islands, Guam, New Caledonia, Northern Mariana Islands and Wallis and Futuna were mentored and guided by higher qualified BWF Coaches. Janelle Pangilinan (NMP) attended the Player Development Tier 2 training camp in Thailand to continue upskilling her coaching knowledge. Under the guidance of Janelle and Nate Guerrero (NMP) Northern Mariana Islands won the bronze medal at the Oceania Junior Championships, this was their first time participating in this tournament beating some more experienced countries.

GROWTH DISCIPLINES

PARA BADMINTON

Notable activities and achievements for 2025

- Record number of entries into the 2025 Oceania Para Badminton Championships of 57 players from 41 in 2023. 5 countries represented in 2025 an increase from 4 in 2023.
- MOU established between Badminton New Zealand (BNZ) and Badminton Oceania (BOC) to collaborate to foster the growth of para badminton. While BNZ focused on growth and participation, BOC focused on development of the competition group. This led to training hubs in five locations throughout New Zealand. Two standing and one wheelchair camps were held, with Ian Bridge-Para Falcons Head Coach leading the wheelchair camp. 11 athletes participated in the Oceania Para Badminton Championships with multiple podium finishes.
- Country visit to PNG by Dhanny Oud as part of the Inclusive GymBad programme with guest coach Wojtek Czyz; to prepare athletes for the Oceania Para Badminton Championships and utilize Wojtek's time to visit and speak at local villages about para badminton.
- Development Officer Dhanny Oud attended the BWF Education Hub in Dubai to undergo BWF L1 and Disability Module Tutor training and certification.
- Country visit to Vanuatu by Dhanny Oud to prepare athletes and coaches for Oceania Para Badminton Championships.
- VICTOR Oceania Para Badminton Championships were held concurrently with YONEX Bendigo International in Bendigo, Australia; a world first to have a Grade 3 international tournament and CC Para Badminton Championships being played in the same venue at the same time. This was followed by the YONEX Australian Para Badminton International.
- A first for Vanuatu's Jacklynda Molidu, attending her first international tournaments, winning a bronze medal at the VICTOR Oceania Para Championships, and winning silver and bronze in the YONEX Australian Para Badminton International.
- A BWF Disability Coach Module course was delivered by BOC in Auckland, New Zealand. 9 coaches attended the course, 3 gained certification (remaining awaiting BWF L1 Coach qualification).
- A BWF Disability Coaching Module Course was delivered by Ian Bridge in Sydney, Australia. 4 coaches attended the course, 3 gained certification (remaining awaiting BWF L1 Coach qualification).
- Congratulations to Pinakin Godse (AUS) who qualified as an International Qualifier.

AirBadminton

Badminton Oceania

With increased priority on AirBadminton from the BWF we saw several new initiatives undertaken during 2025; most notably:



Regular AirBadminton sessions open to the public on the beach in Noumea (NCL)

AirBadminton was chosen activity for the Northern Marianas Youth Advisory Group project – organising an AirBadminton Jamboree for school pupils, which was a huge success with this young age group.



BOC staff implemented an afternoon of AirBadminton on the sand as an introduction to AirBadminton for the players who played in the Oceania Junior Championships. Players were divided into teams, provided with an AirBadminton cap, and played 4 a-side competition which became highly competitive.

Australia held the first AirBadminton National Championships in the region, in Brisbane in June. From this tournament a team went on to represent Australia in the Asia Pacific Championships in Malaysia in August and the BWF AirBadminton World Cup in Sharjah in December. The player experience has been extremely positive with AirBadminton increasing in popularity in Australia.



We also saw unstructured community activity in five Pacific MAs.

AirBadminton continues to serve an important purpose in making badminton accessible to communities in the Pacific with limited facilities. The AirBadminton equipment is well used in community and school visits throughout Oceania, making it a key element of Shuttle Time delivery as well as providing the opportunity for competitions.

INCLUSION



is the Australian Government's sport for development programme comprising of 35 programmes across the Pacific that are working towards three outcomes:

1. **Sport programs attract and retain women, girls and people with a disability, as well as men and boys;**
2. **Sport organisations are safe, inclusive and accessible;**
3. **Australia and Asia-Pacific partners use sport to strengthen relationships and build closer collaboration.**

These three outcomes all contribute to Team Up's overall goal: Australia-Pacific sport partnerships support all people to realise their full potential through sport.

Badminton Oceania is the lead partner of the Team Up Inclusive GymBad programme in Papua New Guinea, in collaboration with Badminton PNG, Gymnastics PNG, and Interplast Australia & New Zealand. Inclusive GymBad aims to remove or reduce the barriers experienced by people with a disability, particularly women and girls, to participate equally. The Shuttle Time and GymAbility programmes are utilised to deliver inclusive activities and encourage women and girls and people with disability to develop leadership skills. A number of these leaders have shared how the programme has made a positive impact in their lives becoming role models for their communities- demonstrating the true benefit that Inclusive GymBad has had on participants.

A workforce of 2 in-country staff and 9 regular volunteer coaches (45% female), and people with and without a disability demonstrate to communities that the programme is for everyone.

There were 25 regular athletes at the triweekly Para Badminton trainings, 1,230 unique participants went

through the Shuttle Time programme (53% Female, 19.5% People with Disabilities), and the Inclusive GymBad team maintained a weekly session at Callan Services Inclusive School in Port Moresby.

In March, BOC Development Officer Dhanny Oud and New Zealand Paralympic badminton player Wojtek Czyz conducted a country visit to PNG, where they had a key focus to prepare the PNG para badminton team for the Oceania Para Badminton Championships later in the year, and to elevate the profile of the Inclusive GymBad programme through community visits featuring volunteer coaches, programme staff, and Wojtek Czyz. There was positive exposure for the Inclusive GymBad programme during this period with several features on the national 6pm news during their time in Port Moresby. Dhanny also delivered the first Shuttle Time Youth Leadership workshop to be run in PNG with participants from Vabukori village.

In August, the Inclusive GymBad team returned to Goroka, Eastern Highlands Province to continue development of a localised programme there. 11 local volunteers were trained as Shuttle Time Teachers, building on the 9 trained in 2024, and continued to deliver to participants through the end of the year.

In October, the largest PNG team to ever attend the Oceania Para Badminton Championships and Australian Para Badminton International, travelled to Bendigo, with 9 players competing. The team was led by Wojtek Czyz as coach, with current player and trainee coach Dorna Longbut assisting, while undergoing coach development. PNG won 8 medals in the Oceania Para Badminton Championships, highlighted by a Gold in the Mixed Doubles SL3-SU5 by Regina Edward and her partner Thomas Slade (NZL). They also won four bronze medals in the Australian Para Badminton International earning the players valuable world ranking points. Several players qualified for the 2026 BWF World Championships however were unable to accept their invitation due to funding restraints.



SPECIAL OLYMPICS

BOC in partnership with Badminton North Harbour in NZL delivered the Wider Auckland Intellectual Disability Inclusive Badminton Programme. Across 17 sessions during the year, the average attendance was just over 20. This was the first step in making badminton more accessible to the Intellectual Disability community in New Zealand, with participant demand and volunteer support driving its success forward.

Guam held their annual Special Olympics 10-week programme in partnership with Special Olympics Guam culminating in a Unified Badminton tournament including members of the badminton community, and badminton continued to be delivered as an offering during Special Olympics Samoa's bi-monthly multisport games.

BOC, Badminton PNG, and Special Olympics PNG collaborated on a sending a team to the Special Olympics Asa Pacific regional badminton tournament in September. 4 athletes and a delegation of 5 supporting volunteers attended in Kuala Lumpur. Roberto Napoleon earned a silver medal in Men's Singles, with Emmanuel Sevara and Roberto Napoleon achieving a bronze medal in Men's Doubles. In the lead up to the SOAP competition, Badminton PNG & Special Olympics PNG strengthened their partnership by delivering a Shuttle Time Teachers course to the Special Olympics PNG volunteer workforce, collaborating on a community visit, co-delivering a local Special Olympics badminton tournament, and including the Special Olympics participants in the tri-weekly Inclusive GymBad sessions in the lead up to the tournament.



FINANCIAL REPORT

In 2025 we contracted Xtreme Productivity to oversee our finances to ensure that we were meeting all requirements of the newly introduced New Zealand Incorporated Societies Act 2022, which we need to comply with as our incorporations under the new Act was approved in May 2025. This resulted in some changes to the day-to-day financial processing and reporting particularly with regards to internal transactions.

We had an approved budget surplus of \$21,495, returning a surplus of 38,492 which was due to:

- Favourable USD exchange rate conversions against budget – \$26,916
- Increased entry fees from Oceania Championships – \$19,522
- Currency gains of \$15,657


We had a significant drop in interest received, from a budget of \$45,000 to actual of \$29,667 reflecting the current economic climate.

Due to the increased income, we were able to invest more funds into various programme areas; specifically, Player Development, Para Badminton, Tournaments including support to players and hosts.

The Executive Board revised our reserves policy in April to:

- A Continuity Reserve Fund to support on-going activities and management in times of change and/or downturn, at a minimum of 25% of the last 3 years average revenue
- Restricted Reserves for investment in strategic development, activities and equipment. The aim is to maintain a minimum of NZD\$100,000.

At the conclusion of 2025 both Reserve Funds met the above criteria providing a level of comfort for future sustainability.

Our Purpose

Badminton Oceania Confederation Inc exists to promote, develop and govern the sport of badminton throughout the Oceania region for the public benefit.

The Confederation supports **18 Member Associations** and works to ensure badminton is accessible, inclusive and sustainable across diverse island and continental nations.

Service Performance Objectives for the Year

During the year ended 31 December 2025 the Confederation focused on delivering programmes and activities intended to:

- Increase participation in badminton across the Oceania region
- Deliver regional championships and sanctioned international tournaments
- Strengthen the capability and governance of Member Associations
- Develop coaches, athletes and technical officials
- Support athlete performance pathways
- Expand emerging disciplines including Para Badminton and Air Badminton.

The performance measures reported below represent the key activities delivered during the year that contributed to achieving these objectives.

Service Performance Framework

Statement of Accounting Policies

Badminton Oceania Confederation (INC)

For the year ended 31 December 2025

Reporting Entity

Badminton Oceania Confederation (INC) is an incorporated society registered under the Incorporated Societies Act 2022. The Society is a Not-For-Profit organisation that promotes Badminton as a sport for people of all ages and all abilities.

Basis of Preparation

This performance report is prepared in accordance with the XRB's Tier 3 (NFP) Standard. The entity is eligible to apply these requirements as it does not have public accountability and has total annual expenses of less than \$5million. All transactions in the performance report are reported using the accrual basis of accounting. This performance report is prepared under the assumption that the entity is a going concern and will continue to operate for the foreseeable future.

Statement of Service Performance (Measurement Basis)

Service performance measures are derived from programme records maintained by the Confederation and its member associations. Participation figures represent total registered participants during the reporting period. Programmes delivered are counted upon completion of each organised event or training session.

Revenue Recognition

Revenue is recognised to the extent that it is probable that the economic benefit will flow to the Society and the revenue can be reliably measured. Revenue is measured at the fair value of the consideration received. The following specific recognition criteria must be met before revenue is recognised.

Donations, fundraising and other similar revenue

Donations are recognised as revenue upon receipt. Grant revenue includes grants given by the Badminton World Federation. Grant revenue is recognised when the entity has satisfied the conditions attached to the funding. Where grant funding is received subject to conditions that have not yet been fulfilled, the amounts are recognised as a liability (deferred grant funding) until such conditions are satisfied.

Revenue from providing Goods and Services

The Confederation receives revenue from team events and special projects within the Oceania region. Revenue is recognised in the period the goods and services are provided.

Interest Revenue

Interest revenue is recognised as it accrues.

Cost Recoveries

Cost recoveries represent amounts recharged to funded programmes and partner organisations in respect of shared operational costs. These amounts are recognised as revenue when the related services are provided and are presented gross within revenue.

Accounts Receivable

Accounts Receivable are recognised initially at fair value and subsequently measured at amortised cost using the effective interest method, less an allowance for any uncollectible amounts. Individual debts that are known to be uncollectible are written off in the period that they are identified.

Foreign Currencies

Transactions in foreign currencies are converted at the New Zealand rate of exchange ruling at the date of the transaction. At balance date, foreign monetary assets and liabilities are translated at the closing rate, and variations arising from these transactions are included in the Statement of Financial Performance.

The effect of exchange rate changes on cash reflects revaluation of foreign-currency cash balances at year end, Related foreign exchange movements are presented in the statement of Financial Performance in accordance with the entity's accounting policies.

Amounts held in foreign currency at balance date are shown at the NZD spot rate for that currency.

Bank Accounts and Cash

Cash and short-term deposits in the Statement of Financial Position and Statement of Cash Flows comprise cash balances and bank balances (including short-term deposits) with original maturities of 90 days or less.

Property Plant and Equipment

Items of property, plant and equipment are measured at cost less accumulated depreciation and impairment losses. Depreciation is charged on a diminishing value basis over the useful life of the asset, except for land. Land is not depreciated. Depreciation is charged at rates calculated to allocate the cost or valuation of the asset less any estimated residual value over its remaining useful life:-

Computer Equipment	40% DV: Diminishing Value is being used.
Furniture & Fittings	20% DV: Diminishing Value is being used.

Depreciation methods, useful lives and residual values are reviewed at each reporting date and are adjusted if there is a change in the expected pattern of consumption of the future economic benefits or service potential embodied in the asset. An item of property, plant and equipment is derecognised upon disposal or when no further future economic benefits are expected from its use or disposal. Any gains or loss arising on derecognition of the asset (calculated as the difference between the net disposal proceeds and the carrying amount of the asset) is included in profit or loss in the year the asset is derecognised.

Income Tax

The Society is approved as an amateur sports promoter and is therefore exempt from income tax under the Income Tax Act 2007.

Goods and Services Tax (GST)

The entity is registered for GST. All amounts are stated exclusive of goods and services tax (GST) except for accounts payable and accounts receivable which are stated inclusive of GST.

Employee Entitlements

Provision has been made for Badminton Oceania Confederation (INC)'s liability for annual leave. Employee entitlements to annual leave are recognised when they accrue to employees and are measured at the amount expected to be paid when the liability is settled.

Leases

Operating Leases

Operating lease payments, where the lessors effectively retain substantially all the risk and benefits of ownership of the leased items, are recognised as an expense in the profit and loss on a straight-line basis over the lease term. Operating lease incentives are recognised as a liability when received and subsequently reduced by allocating lease payments between rental expense and reduction in liability.
