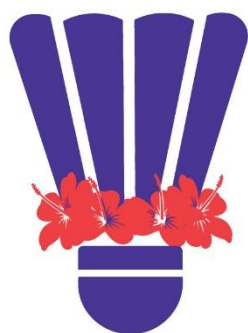

Regulations (Conditions of Play)	<p>This tournament will be conducted in accordance with, but not limited to, the Badminton World Federation (BWF) Statutes and General Competition Regulations (GCRs) and the Badminton Oceania Grade 3 Tournament Regulations. In the event of any dispute, the decision of the Tournament Referee will be final.</p> <p>Clothing and advertising are in accordance with the BWF General Competition Regulations (sections 20-24). The name of the player is MANDATORY on the back of all the players' shirts. The country name is optional, however if it is on the shirt, it must comply with BWF regulations. Quarterfinals onwards GCR 21 regarding clothing colour will apply:</p> <ul style="list-style-type: none"> • In Singles matches opposing players must wear significantly different coloured clothing • In doubles matches both players must wear the same colour clothing and opposing pairs must wear significantly different coloured clothing

Entry Fees	<p>All players are required to pay entry fees.</p> <p>The entry fee for international players is USD170 The fee for local players is USD50 Member Associations will be invoiced on Wednesday 15 July with payment due by Friday 17 July 2026.</p> <p>Players will not be given an accreditation pass until the entry fee is paid.</p> <p>The Member Association that enters a player into the tournament is responsible for paying the entry fees for that player. Entry fees become due if a player is entered and has not been withdrawn by the time when the draw is made. Entry</p>																								

fees are due for all players including any who withdraw once the draw is made. Entry fees will not be refunded in the case of a withdrawal.

The entry deadline is **Tuesday 23 June 2026** at 23:59, BWF Headquarters time (+08:00 hrs GMT). Late entries will not be accepted.

After the entry deadline, the BWF Online Group Entry System will send notification to all participating Member Associations confirming receipt of final entries. Receipt of this notification is the conclusive evidence of receipt of entries before the deadline.

Member Associations should contact BWF immediately if such notice is not received by Wednesday 24 June 2026 at 12:00 hrs BWF Headquarters time.

If no objection is received by BWF by Thursday 25 June 2026 at 23:59 hrs BWF Headquarters time, the entries shall be deemed to be correct. No complaints/objections will be entertained after this point.

Withdrawals

Withdrawals will be managed according to the BWF GCR 11, 13 & 14 regulations.

Members can withdraw their entries through the BWF Online Group Entry system by logging onto the tournament link used for lodging the entry until **Monday 13 July 2026**.

Withdrawals after this date shall automatically attract withdrawal fees as per [BWF Table of Offences and Penalties](#).

<p>Presentation Ceremonies</p>	<p>All prize ceremonies will take place on Saturday 25 July immediately after the conclusion of each final. Trophies will be presented to all champions and finalists.</p> <p>No equipment, including rackets and flags, is allowed to be brought onto the podium. Clothing worn during the ceremony must be in accordance with the BWF GCR.</p>

Anti-Doping

Doping control in badminton, in accordance with BWF Anti-Doping Regulations, is conducted out- of-competition and in-competition with the collection of urine and/or blood samples.

Athletes are responsible for any substance found in their body. Before an athlete takes any medication, they should check with their doctor, and if necessary, get a Therapeutic Use Exemption (TUE).

Badminton Integrity

Section 2.4 of the BWF Statutes (Code on The Prevention of The Manipulation of Competitions) relates to anti-corruption and anti-match manipulation, and this code applies to all participants at this tournament.

To protect the integrity of BWF sanctioned tournaments, participants are not allowed to bet in any way on badminton matches, shall respect the principle of fair play, and shall not attempt to influence the course or result of a game or match.

Every person has an obligation to report to the BWF any approaches by anyone to gather inside information or to change the outcome of a match(s).

GCR 7.9:

"In making or authorising entries, the Member concerned is reconfirming its acceptance, and acceptance by the Players being entered, of the BWF's regulations and Disciplinary processes."

3. Travel & Visa Details

Transport

Transport will ONLY be provided to players and officials staying at the official tournament accommodation provider – The Crowne Plaza

Transport includes airport pick-up and drop-off, to and from practice and the tournament venue.

Airport transfers will be provided from Saipan International Airport to the CROWNE PLAZA HOTEL upon request. Please complete and submit the flight details form no later than **Friday 10 July 2026**. Requests after this date cannot be accepted. Requests for a refund of taxi charges will not be entertained.

Departure flight details must be confirmed at least two (2) days in advance to the Tournament Organisers.

Visas

The Northern Mariana Islands are a USA territory therefore anyone coming to the Northern Mariana Islands must meet USA requirements.

U.S.A VISA APPLICATION PROCESS

1. Players and officials whose country are not under the visa waiver program, visit <https://travel.state.gov/content/travel/en/us-visas.html> to apply for United States visa.
2. Choose Non-Immigrant Visa, B-1.
3. Fill out form and submit requirements.

Set up appointment for interview and pay fee.

You may be required to appear at the U.S. Embassy or Consulate at your country of origin for interview with the consular officer. For more information, check <https://travel.state.gov/content/travel/en/us-visas/tourism-visit/visitor.html>

If you require a visa support letter, please complete the VISA Letter Request Form and email to: roselynmonroyo@gmail.com no later than Tuesday 23 June 2026.

We recommend applying at least 45 days prior to your planned travel dates.

If your country is under the Visa Waiver Programme, you need to apply for an ESTA.

WHO SHOULD APPLY?

- You are a citizen or eligible national of a Visa Waiver Program country.
- You are currently not in possession of a visitor's visa.
- Your travel is for 90 days or less.
- You plan to travel to the United States for business or pleasure.
- You want to apply for a new authorization for one person or a group of applications for two or more persons.

WHAT DO I NEED TO APPLY?

- Valid passport(s) from a Visa Waiver Program country.
List of Visa Waiver Countries
- Traveler's valid email address.
- Traveler's home address and phone number.
- Traveler's emergency point of contact phone and email.
- **Payment method:**
Fee for application is \$21.00 USD.
Valid payment methods include MasterCard, VISA, American Express, Discover (JCB or Diners Club only), and PayPal.

- Traveler's aliases or other names (If Applicable).
- Traveler's National ID or Personal ID number (If Applicable).
- Traveler's Global Entry ID number (If Applicable).
