After the entry deadline, the BWF Online Group Entry System will send notification to all participating Member Associations confirming receipt of final entries. Receipt of this notification is the conclusive evidence of receipt of entries before the deadline.

Member Associations should contact BWF immediately if such notice is not received by Wednesday 17 June 2026 at 12:00 hrs BWF Headquarters time.

If no objection is received by BWF by Thursday 18 June 2026 at 23:59 hrs BWF Headquarters time, the entries shall be deemed to be correct. No complaints/objections will be entertained after this point.

Withdrawals

Withdrawals will be managed according to the BWF GCR 11, 13 & 14 regulations.

Members can withdraw their entries through the BWF Online Group Entry system by logging onto the tournament link used for lodging the entry until **Monday 6 July 2026**.

Anti-Doping

Doping control in badminton, in accordance with BWF Anti-Doping Regulations, is conducted out- of-competition and in-competition with the collection of urine and/or blood samples.

Athletes are responsible for any substance found in their body. Before an athlete takes any medication, they should check with their doctor, and if necessary, get a Therapeutic Use Exemption (TUE).

Badminton Integrity

Section 2.4 of the BWF Statutes (Code on The Prevention of The Manipulation of Competitions) relates to anti-corruption and anti-match manipulation, and this code applies to all participants at this tournament.

To protect the integrity of BWF sanctioned tournaments, participants are not allowed to bet in any way on badminton matches, shall respect the principle of fair play, and shall not attempt to influence the course or result of a game or match.

Every person has an obligation to report to the BWF any approaches by anyone to gather inside information or to change the outcome of a match(s).

3. Travel & Visa Details

Transport

Transport will ONLY be provided to players and officials staying at the official tournament accommodation provider – The Crowne Plaza

Transport includes airport pick-up and drop-off, to and from practice and the tournament venue.

Airport transfers will be provided from Saipan International Airport to the CROWNE PLAZA HOTEL upon request. Please complete and submit the flight details form no later than **Friday 3 July 2026**. Requests after this date cannot be accepted. Requests for a refund of taxi charges will not be entertained.

Departure flight details must be confirmed at least two (2) days in advance to the Tournament Organisers.

The Northern Mariana Islands are a USA territory therefore anyone coming to the Northern Mariana Islands must meet USA requirements.

WHO SHOULD APPLY?

- You are a citizen or eligible national of a Visa Waiver Program country.
- You are currently not in possession of a visitor's visa.
- Your travel is for 90 days or less.
- You plan to travel to the United States for business or pleasure.
- You want to apply for a new authorization for one person or a group of applications for two or more persons.

WHAT DO I NEED TO APPLY?

- Valid passport(s) from a Visa Waiver Program country.
List of Visa Waiver Countries
- Traveler's valid email address.
- Traveler's home address and phone number.
- Traveler's emergency point of contact phone and email.
- **Payment method:**
Fee for application is \$21.00 USD.
Valid payment methods include MasterCard, VISA, American Express, Discover (JCB or Diners Club only), and PayPal.

The following information may also be required:

- Traveler's aliases or other names (If Applicable).
- Traveler's National ID or Personal ID number (If Applicable).
- Traveler's Global Entry ID number (If Applicable).
- Traveler's employer address and phone number (If Applicable).
- Traveler's U.S. point of contact name, address, and phone (If Applicable).

U.S.A VISA APPLICATION PROCESS

1. Players and officials whose country are not under the visa waiver program, visit <https://travel.state.gov/content/travel/en/us-visas.html> to apply for United States visa.
2. Choose Non-Immigrant Visa, B-1.
3. Fill out form and submit requirements.

Set up appointment for interview and pay fee.

If you require a visa support letter, please complete the VISA Letter Request Form and email to: roselynmonroyo@gmail.com no later than Tuesday 16 June 2026.

We recommend applying at least 45 days prior to your planned travel dates.

If your country is under the Visa Waiver Programme, you need to apply for an ESTA.
